 The proposed location for the cultivation facility is on private property with the closest public access more that 200 feet away.

2. The only road access is on a gated 1.2 mile private road.

Where the private property that the cultivation facility is located abuts the easement for the private road there will be no trespassing signs every 100 feet.

4. The restricted access area designated RAA 1 (high tunnel) will have a six foot fence around the area with one locking gate, all sides and gate will have the RAA signage.

The restricted access area designated RAA 2 (drying/possessing area) will have two points of entry, each point of entry will have a commercial grade door and lock set, and RAA signage.

Describe your processes for admitting visitors into and escorting them through restricted access areas:

 Visitors will be required to show a valid government issued picture id, a copy of the id will be made and kept on file as a business record (this needs to be done only once in cases of multiple visits.

2. Visitors will be given the facilities sanitary and safety brief, and then sign the access log.

Visitors will then be issued a visitors badge, there will be no more that five visitors per employee.

4. At end of visit, visitors will return visitor badges and sign out.



1. Any employee caught stealing will be immediately terminated and may be prosecuted. All employees will be made aware of this policy during pre-employment interview.

Plants under cultivation will be routinely inspected and physical characteristics entered in the growers log and the state tracking system.

- 3. All drying and processing will be done under video surveillance.
- Final weights and plant counts will be entered into the growers log and log checked for continuity.
- 5. The cultivation facility will fully implement the state tracking system.


The cultivation facility will be wholly located on private property with the closes "public" access over 200 feet away. No unauthorized access to the property will be allowed.
 Where the private property that the cultivation facility is located abuts the easement for the private road there will be no trespassing signs every 100 feet.
 Any person found on the property will be escorted off the property or held for local law

enforcement if the situation warrants.

1. The gate will have sensors to detect persons or vehicles. These systems are active 24 hours per day and are independent of the security system.

RAA 1 and 2 will have motion detectors installed. These sensors are part of the security system.



Describe how the video cameras will be placed to produce a clear view adequate to identify any individual inside the licensed premises, or within 20 feet of each entrance to the licensed premises:

1. RAA 1 will have four video cameras placed on two 20 foot towers. The towers will be located in opposite corners, just inside of the fenced in area surrounding the high tunnel. Each video camera will be mounted on an arm so that the camera is positioned over the corner of the fence. The video cameras "see" in a 70 degree arc and will be placed in such a fashion so as to have about 10 degrees of overlap this will permit each tower to monitor approximately 120 degrees and provide complete exterior coverage of RAA 1. One of these cameras will also monitor the exterior door of RAA 2. RAA 1 will have one camera located inside of the high tunnel, placed in such a position so as to clearly view the door and as much of the grow area as possible.

2. RAA 2's exterior door will be monitored by one of the cameras located at RAA 1. The interior of RAA 3 will have two cameras installed in such a way so that the interior of both doors, the scale, and storage areas will be monitored. One camera will be mounted in the office to monitor the exterior of the door into the restricted access area.

Describe the locked and secure area where video surveillance recording equipment and records will be housed and stored and how you will ensure the area is accessible only to authorized personnel, law enforcement, or an agent of the board:


 The video surveillance recording equipment will be secured in a fire rated steel "gun" type safe. The safe will be mounted to the floor in RAA 2 and will be monitored by a security camera.


