Dear Tundra Fire LLC:

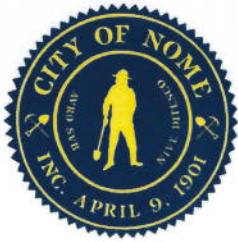
This letter is to inform you that your license applications for marijuana licenses number 10677 and 10678, Tundra Fire, LLC, is being placed on the agenda for the MCB meeting September 7-8, 2016 in Anchorage for consideration of denial of the license.

The reason the board must consider denial is because you have publically noticed that your cultivation facility will be located within 500 feet of a youth center. 3 AAC 306.010(a) states that "the board will not issue a marijuana establishment license if the licensed premises will be located within 500 feet of a . . . youth center."

We did check with the City of Nome and confirmed that your premises address which you publically noticed is within 500 feet of the Checkpoint Youth Center.

Please plan to attend the board meeting regarding this application, either in person or by phone. Because your applications have only been initiated, please do not attempt to pay the fees to move these applications to under review status before the board meeting. Payment will not be accepted at this time.

RESOLUTION NO. R-16-08-03

A RESOLUTION AUTHORIZING THE CITY CLERK TO FILE A FORMAL PROTEST WITH THE STATE OF ALASKA ALCOHOL AND MARIJUANA CONTROL OFFICE ON THE COMMERCIAL MARIJUANA LICENSE APPLICATIONS FROM TUNDRA FIRE LLC

WHEREAS, in August of 2015, the Nome City Council, by Ordinance O-15-08-03, opted to serve as the community's local marijuana regulatory authority; and,

WHEREAS, Tundra Fire LLC has submitted two commercial marijuana applications with the State of Alaska, both for the old Anchor Liquor Store located at 229 Front Street; and,

WHEREAS, the Checkpoint Youth Center is currently situated in the old Arctic Trading Post located at 302 Front Street; and,

WHEREAS, the State of Alaska Marijuana Regulations specifically state that no marijuana establishment shall be within 500' (as measured by the shortest pedestrian route) of a youth center; and,

WHEREAS, as the crow flies, the front door of 229 Front Street has been measured by City Officials as 375' from 302 Front Street; and,

WHEREAS, using sidewalks and right angles, the front door of 229 Front Street has been measured by City Officials as 466'9" from 302 Front Street; and,

WHEREAS, also using sidewalks and right angles, the side door of 229 Front Street has been measured by City Officials as 541'8" from 302 Front Street.

NOW, THEREFORE, BE IT RESOLVED by the Nome Common Council that the City Clerk shall file an official protest with the State of Alaska Alcohol and Marijuana Control Office on the commercial marijuana license applications from Tundra Fire LLC.
