Between the September board meeting and this one, eighteen NOVs have been issued as summarized below. Also included are two advisory notices distributed to different groups of licensees.

• AB17-0368 to Dankorage (#10306), a retail store in Anchorage, for numerous inventory tracking violations. (3 AAC 306.330; 3 AAC 306.755)

AB17-0370 to Dankorage (#10306), a retail store in Anchorage, for an inventory tracking violation (3 AAC 306.330) found during a random audit, where approximately 58 grams of bud/flower could not be accounted for.

AB17-0380 to Dankorage (#10306), a retail store in Anchorage, for having personal marijuana plants that are not tracked in the inventory tracking system on the licensed premises, and for utilizing an area of the building that was not shown on their licensed premises diagram and thus not approved by the board. (AS 17.38.070; 3 AAC 306.730; 3 AAC 306.755; 3 AAC 306.020)

An accusation is forthcoming.

• AB17-0371 to Coyote & Toad's Garden (#10141), a limited cultivation facility in Skagway, for "numerous errors regarding packages not relating back to a harvest batch."

Although licensees are not required to respond to NOVs, we are concerned that this licensee has not responded. We are attempting to determine whether the license has contacted Metrc about how to correct the errors.

• AB17-0379 to JWS Enterprises (#10657), a standard cultivation facility in Ketchikan, for creating packages that are not tied to a harvest batch, in violation of 3 AAC 306.435.

Although licensees are not required to respond to NOVs, we are concerned that this licensee has not responded. We are attempting to determine whether the license has contacted Metrc about how to correct the errors.

• AB17-0384 to Fat Tops, LLC (#11140), a retail store in Soldotna, for employees who were not properly credentialed, in violation of 3 AAC 306.320 and 3 AAC 306.710.

AB17-0387 to Fat Tops, LLC (#11138), a standard cultivation facility in Soldotna, for inventory violations, where the number of clones in the facility did not match the number shown in Metrc, violation 3 AAC 306.405, 3 AAC 306.435, and 3 AAC 306.730.

AB17-0395 to Fat Tops, LLC (#11140), a retail store in Soldotna, for an advertising violation (3 AAC 306.360).

The licensee has requested to appear before the board.

- AB17-0386 to Cannabaska (#10236), a retail store in Anchorage, for inventory tracking violations (3 AAC 306.330) found during a random audit, where approximately 46 grams of bud/flower could not be accounted for.
- AB17-0396 to Rainforest Cannabis (#10883), a retail store in Ketchikan, for violation of advertising restrictions (3 AAC 306.360)
- AB17-0398 to Pine Street Cannabis Company (#10273), a retail store in Soldotna, for transferring marijuana from a cultivation facility to a retail facility in Metrc, but not physically moving the marijuana. (3 AAC 306.330)
- AB17-0402 to Flying High Investments, LLC (#10268), a standard cultivation facility in Chitina, for falsification of transportation manifests.

The licensee generated two manifests (ending in 93808 and 93809) that were for overlapping times and indicated that the transfer of marijuana would occur using a car, while in fact the transportation was by private aircraft. In his response, counsel for the licensee states that because his car was breaking down, the licensee switched to his aircraft and noted this on the manifests. Additional documentation shows that the manifests provided by Grass Station 49 and Chena Cannabis do not contain the notes on the manifests that the licensee provided, indicating they were added later. Text messages from one of the recipients show that the licensee intended at least a day in advance to fly his private aircraft to transfer marijuana. An accusation will be forthcoming.

The licensee has requested to appear before the board.

- AB17-0404 to Permafrost Distributors (#11509), a retail store in Sterling, for an inventory tracking violation (3 AAC 306.330) found during a random audit, where approximately 32 grams of bud/flower could not be accounted for.
- AB17-0408 to Red Run Cannabis Company, LLC (#10056), a retail store in Kenai, for a violation of the advertising restrictions in 3 AAC 306.360(b).

The licensee has requested to appear before the board.

- AB17-0427 to Alaskan Leaf, LLC (#10577), a retail store in Anchorage, for not reconciling its point-of-sale system with Metrc daily, as required by 3 AAC 306.330(c), and for processing marijuana outside of the restricted access area, a violation of 3 AAC 306.710(a).
- AB17-0436 to Fat Tops, LLC (#11140), a retail store in Soldotna, for inventory violations (unable to account for about 35 grams of marijuana) and storing marijuana off the licensed premises, which are violations of 3 AAC 306.330 and 3 AAC 306.305.

Licensee did not respond to provide an explanation.

- AB17-0460 to AK Slow Burn Cannabis Outlet (#10245), a retail store in Anchorage, for inventory tracking violations (3 AAC 306.330; 3 AAC 306.730) found during a random audit, where approximately 207 grams of leaf/trim could not be accounted for. Additionally, the product was not weighed when it was received from another licensee in violation of 3 AAC 306.730(b) and 3 AAC 306.750(e).
- AB17-0461 to The Frost Frontier (#10161), a standard cultivation facility in Anchorage, for a self-reported inventory tracking system error. A solution to correct the problem was established, but was not implemented by the licensee, which caused additional record keeping errors.

Note: This is not an accusation or a criminal complaint.

Current regulations only require that one test sample to be submitted for testing regardless of harvest batch size.

Our cultivation regulations make reference to harvest batches in two sections as you will see below. The problem is that our regulatory definition of batch or harvest requires said batches to be a specifically identified amount. Moreover that definition will not always be synonymous with what is generally termed as a harvest batch in metrc. Only 3 AAC 306.435 (marijuana inventory tracking system) specifically defines the batch as not exceeding 5 pounds. 3 AAC 306.455 (required laboratory testing) requires a sample from strain specific batches but it does not specify the batch size nor does it cross reference 3 AAC 306.435 to say that the 5lb limit specified there is applicable.

- 3 AAC 306.455 Required laboratory testing states (a) A marijuana cultivation facility shall provide a sample of each harvest batch of marijuana produced at the facility to a marijuana testing facility and may not sell or transport any marijuana until all laboratory testing required under 3 AAC 306.645 has been completed. (b) To comply with (a) of this section, a marijuana cultivation facility shall (1) collect a random, homogenous sample for testing by segregating harvested marijuana into batches of individual strains of bud and flower, then selecting a random sample from each batch in an amount required by the marijuana testing facility;
- 3 AAC 306.435. Marijuana inventory tracking system. (a) A marijuana cultivation facility shall use a marijuana inventory tracking system in compliance with 3 AAC 306.730 to ensure all marijuana propagated, grown, or cultivated on the marijuana cultivation facility's premises is identified and tracked from the time the marijuana is propagated through transfer to another licensed marijuana establishment or destruction. The marijuana cultivation facility shall assign a tracking number to each plant over eight inches tall. When harvested, bud and flowers, clones or cuttings, or leaves and trim may be combined in harvest batches of distinct strains, not exceeding five pounds. Each harvest batch must be given an inventory tracking number.

Dankorage did not following instructions provided by METRC on zeroing out packages 1A40203000017D7000000263, 1A40203000017D7000000264 on 6-15-17.

On 7-4-17 Dankorage combined packages 1A40203000017D7000000251 and 1A40203000017D7000000252 in package 1A40203000017D7000000268, this was done incorrectly and the notes do not reflect the amounts transferred and do not indicate where the package went or came from in METRC.

Dankorage has a negative number in METRC with Package 1A40203000017D7000000263. Package is at -3.75 pounds and should be at 0.

Package 1A40203000017D7000000268 indicates 2007.17 grams currently remaining in METRC, AMCO audit found 263.13 grams which leaves 1744.04 grams unaccounted for and no way to explain or track this discrepancy between METRC and product found during the audit.

Dankorage made 154 sales from Package 1A40203000017D7000000264 after it should have been zeroed out.

Package 1A40203000017D7000000269 has 483.35 remaining in METRC, AMCO found 122.6 Grams which leaves 360.75 grams improperly tracked in METRC.

Dankorage failed to provide requested documentation of the varying amounts tracked in METRC compared to what was found during the audit.

This is a violation of 163 counts of 3 AAC 306.330 Marijuana inventory tracking system and a violation of 3 AAC 306.755 Business Records

The contents of this package was located in 3 separate containers with usable product and one small bag with waste (stems, etc.). The total product weight within these 3 containers was approximately 170g. This left approximately 58g of "su sage" unaccounted for according to your inventory tracking.

This is a violation of 3 AAC 306.330 Marijuana Inventory Tracking System.

On Monday, August 7th, 2017, Investigators from the State of Alaska Alcohol & Marijuana Control Enforcement were in contact with Dankorage, LLC, a retail marijuana store.

During the course of the contact, two mature non-flowering marijuana plants were observed in the Dankorage LLC retail store display area. The two marijuana plants were not tagged with the required METRC RFID tags and they were not tracked by a manifest or received by a licenses cultivator registered within the State approved METRC system. Dankorage LLC owner, Lily Bosshart stated she brought her personal marijuana plants into Dankorage LLC and stood them on display for educational purposes.

This is a violation of:

3 AAC 306.730. Marijuana inventory tracking system.

3 AAC 306. 750. Transportation. (b)(c)(d)(e)(f)

During the same contact, investigators observed that Dankorage LLC was utilizing a storage area below the floor, this storage was referred as the "Hobbit hole" which stored packaging materials for Dankorage LLC. This area was not included into the approved premises diagram.

After review of Coyote & Toad's METRC entries it was found there has been numerous errors regarding packages not relating back to a harvest batch. Package # 1A402030000DAD000000015 showed a package of 2.59 lbs being created from no attributable harvest and then being discontinued two hours later.



Dear Investigators Hamilton and Rukes:

I have been retained by Fat Tops, LLC. to respond to the above three notices of violation recently received. I will address them in the order of their occurrence as follows.

1. AMCO Case# AB17-00395: Violation of 3 AAC 306.360 (c)(3) Restrictions on Advertising of Marijuana and Marijuana Products.

In response, Mr. Parker admits that the sign he placed on what he believed was his property, was over his property line by approximately 10-12 inches. Mr. Parker believed he was within his property, at the time he placed the sign upon the real property. It was not until Mr. Parker met with Mr. Bruce Wall, Planner with Kenai Borough Zoning and Planning, that he found out that his sign was actually in a public right of way area. They located the property lines together, and it was determined that the sign was just over the property line. This was an inadvertent mistake by Mr. Parker, and one not deliberately nor intentionally made. Mr. Parker and Mr. Wall were able to rectify the problem, by moving the sign to inside of Mr. Parker's property line. The sign is no longer within "publicly owned property." The inadvertent mistake, has been rectified, corrected, and will not occur again. All property lines have clearly been established, marked, and Mr. Parker is aware of where they all are at this time. He thought he was aware of where they were previously, but was incorrect. This will not occur again.

2. AMCO Case# AB17-0387: Violations of 3 AAC 306.405; 3 AAC 306.435 and 3 AAC 306.730.

In response to this notice of violation, Mr. Parker is aware of the provisions set forth in 3 AAC 306.405: Standard Marijuana Facility, which at paragraph (a)(4) sets forth in pertinent part ...

any stored inventory must be stored in a restricted access area and accounted for in the marijuana cultivation's facilities inventory tracking system as required under 3 AAC 306.730. 3 AAC306.430, Marijuana inventory tracking system sets forth in pertinent part (a): a marijuana cultivation facility should use an inventory tracking system in compliance with 3 AAC 306.730 to insure all marijuana propagated, grown or cultivated on the marijuana cultivation facility's premises is identified and tracked from the time the marijuana is propagated through transfer to another licensed marijuana establishment or destruction. The marijuana cultivation facility must assign a tracking number to each plant over eight inches tall...."

That at the time the inspection was conducted, Mr. Parker had the correct number of clones listed on paper. However, the incorrect numbers of clones was set forth within the MTRC system. In speaking with Mr. Parker, he indicated to me that his clones are moved for sale into the retail store, or are tagged, the information is placed on paper, and transferred to the office for placement into the MTRC system. At the time of the inspection, updated MTRC information had not been placed within the system. Subsequently, Mr. Parker has changed business protocol and procedure, in that the office will immediately update any and all changes at to marijuana plant count, including clones, at the time any movement and/or change occurs. Not within several hours but immediately. Mr. Parker is now aware, that this needs to be done timely, and that time is of the essence so that the MTRC numbers are actually correct, and reflected in the number of actual plants, or clones.

3. Lastly, in response to AMCO case # AB17-0384, date of occurrence 8/31/17, an alleged violation of 3 AAC 306.320 and 3 AAC 306.710.

At the time of the inspection, there were two of the store employees who were in a restricted area, not wearing their marijuana handler permit as required under 3AAC 306.320 (2). One had apparently taken off her vest, to which her credentials were attached, and a second employee had just arrived to work and had left her card in her vehicle. Being somewhat nervous, and a little confused, the one employee continued to work. She was told by the inspector, "that her correct response would have been to get her credentials from her car" to which she immediately did. It is important to point out, while these employees did not have their cards immediately upon their person as required, both were credentialed with a valid marijuana handler permit as required, and both cards were within date of issue.

Since this occurrence, Mr. Parker has again changed his policies to require a visual inspection each day upon opening that each employee, including Mr. Parker, has their marijuana handler permit affixed or within that person's immediate possession when on the licensed premise or within the restricted access area as set forth under 3AAC 306.710.

Mr. Parker has rectified all of the violations set forth within the three notices. He has changed his business practices as to violation # AB17-0384 and AB17-0387. Lastly, as to violation AB17-000395, Mr Parker has located his property lines so that no advertising will occur in any right-of-way that is "publicly owned property".

Mr. Parker, like many individuals within the marijuana retail operation arena and that of a cultivation facility, find themselves in somewhat of a steep learning curve. Undersigned counsel is now working directly with Fat Tops, LLC to ensure compliance. Furthermore, a private audit of Fat Tops, LLC's MTRC records, is being conducted, and will continue to be conducted on a routine

basis, until such time as it is believed there are no errors within the MTRC system, and that Mr. Parker, including his employees, are comfortable with the operation of the metric system, and its continual updating as required.

It is respectfully requested, that the above violations, not be found, no fine imposed but utilized as a warning, and held in abeyance within Mr. Parker's retail and cultivation files. Mr. Parker, has not, nor would he do anything willful or intentional, to violate any rules set forth within this marijuana industry by the State of Alaska as codified in 3 AAC 306 or other Alaska statutes.

Lastly, Mr. Parker requests to appear before the Marijuana Control Board and be heard regarding the above violations.

Thank you for your time and attention to this matter. We look forward to working with you in building this marijuana industry.

In response to the notice of violation noted above, we are notifying you that we have initiated a new policy to prevent recurrence of the violation in the future.

On 08/18/17 AMCO investigators conducted a random audit of marijuana inventory. They selected 3 random packages from our Metro inventory and compared the reported amounts with the amounts on hand. The following discrepancies were noted with 2 of the 3 packages:

1A4020300001B59000000411 Pineapple X Buds: 57.93g reported in Metrc, 48g on hand. On 9/10/2017 our store manager completed a full audit on all the inventory in the store. This lead to the discovery of the items in question. For item number ending in 0411 we had a total of 5.65 grams of waste in stems and seeds. We also had a total of 4.28 grams lost to moister. At the time we had not recorded this movement in Metrc which lead to the discrepancy at the time of the inspection. We have since updated Metrc and closed this batch. As a company, we have implemented new procedures to our daily operating plan to prevent this from happening again. These new steps are daily morning and night checks of all inventory with the appropriate Metrc action completed at that time of audit.

1A4020300001B59000000407 1- nDun F2 buds: 248.43g reported in Metrc, 212g on hand for item number ending in 0407 there was a total of 36.43 grams missing. The missing amounts were found in our pre-roll area which contained 31.25 grams of the amount in question. There was also 2.73 grams of stems and seeds that was set aside for waste. We also lost 2.45 grams to moister. All of which have been updated and accounted for in Metrc. We have instilled new standard operating procedures as stated above to prevent this from happening in the future.



Note: This is not an accusation or a criminal complaint.

METRC indicates Flying High Investments LLC generated two manifests 0000093808 & 000003809 to deliver product to Grass Station 49 and Chena Cannabis on 8-12-17. Investigation by AMCO Enforcement revealed that product was transported to these locations by private aircraft. The aircraft landed at Bradley Sky Ranch in North Pole first. Licensee/Pilot James Fejes Jr. then contacted Sherry Gilbert, Licensee of Chena Cannabis to pick him up and provide him with transportation to her retail store, then onto Grass Station 49 and back to the aircraft. The METRC manifest created by Flying High Investments, LLC on 8/12/17 reflects James Fejes Jr. drove his personal vehicle to Fairbanks from McCarthy Road, Chitina, AK. The manifest does not reflect any of the transportation of marijuana to ever be by air or any of Sherry Gilbert's vehicle information.

Manifest #0000093103 indicates you left Chitina en route to Wasilla on 8-10-17 at 12:08 am arriving at 12:08 pm using vehicle with a license plate of EAN340. The same day manifest 0000093104 indicates you left Chitina on 8-10-17 at 5:26 am arriving Anchorage on 8-9-17 (I believe this is a typo and should read 8-10-17) at 10:26 am using a vehicle with license plate EAN340. These manifests seem to conflict with each other.

On 7-15, 7-17 and 8-4-17, you used a vehicle with expired license plates, GVB348, expiring 6/16. Your Attention is Directed to: 3 AAC 306.435(b) Marijuana Inventory Tracking System, 3 AAC 306.730(a) Marijuana Inventory Tracking System, 3 AAC 306.750 Transportation, and 3 AAC 306.755(a)(9) Business Records.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice. 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable law.

I have been retained by Licensee James Fejes, Jr., d/b/a Flying High Investments, LLC. to respond to the above notice of violation recently received. I will address them in the order they are set forth within the Notice of Violation.

1. AMCO Case No. AB17-0402:

Alleged Violation of 3 AAC 306.435(b) Marijuana Inventory Tracking System, 3 AAC 306.750 Transportation and 3 AAC 306.755(a)(9) Business Records

A. In response, as to manifest numbers 93808 and 8309, Mr. Fejes originally entered and created the travel manifests within the METRC system in order to deliver marijuana flower to Grass Station 49 and Chena Cannabis. He was scheduled to depart on 8/12/17, at the scheduled time in his personally owned Chevrolet diesel truck. After departing and being en route for approximately an hour, Mr. Fejes encountered unexpected vehicle problems with his truck. The problem was determined to be dirty diesel fuel. It had entered the fuel filter of his truck and clogged it, placing the vehicle in "limp mode." Mr. Fejes turned around to go back to the facility, but his vehicle would not make it as it was getting worse. He instead, went to the airport in Chitina as it was 22 miles closer than his cultivation facility. There, he departed in his airplane once it was loaded for Fairbanks, AK. in order to keep as close as possible to his original and planned schedule of departure and arrival times. While en route, he contacted Sherry with Chena Cannabis and informed her of the issue and the fact he would need a ride once he arrived at Bradley Field. She arrived and transported him along with the product to Chena Cannabis for the scheduled delivery. Once that was completed, he went to Grass Station 49 for the other scheduled delivery.

This change was noted within the "notes" section of the AMCO Marijuana Transportation Manifest which sets forth "details for extenuating circumstances (e.g., road closures, flat tire, etc.) This list is not exhaustive but merely illustrative of types of extenuating circumstances that could be encountered while en route. Reflected in both Mr. Fejes and the retail store's travel manifests this is set forth: "Truck issues switched N766P CXL to Bradley local car." See Ex. 1.

During the investigation phase of this matter, the assigned investigator went to the local retail stores where deliveries had occurred. During this time, not once was there a request to review or copy their travel manifests which clearly documented this extenuating circumstance within the "notes" section. This, despite the fact that both individual retailers indicated what had happened and offered to show them the travel manifest with notes reflecting same. It is believed, had the investigator assigned reviewed this, it would have mitigated any wrong doing on the part of Mr. Fejes. Both of Mr. Fejes's manifests and the retail store manifests indicate the same information. This was not investigated.

Mr. Fejes believed he was doing the correct thing, acting properly and responsibly. Despite being licensed through METRC and having reviewed all the training materials consistent and applicable to his cultivation facility, there is nowhere within the training documentation any information on how to fix and/or correct what occurred with Mr. Fejes during his travels to Fairbanks. The videos are not Alaska specific and made for general application use only. They do not cover all situations and certainly not the type of issue experienced by Mr. Fejes. Cell coverage was not available either at this location at the time of occurrence due to its remote and geographic location.

This issue has arisen based on lack of guidance and training available as to transportation travel manifests dealing with vehicle breakdowns etc. This situation could have been remedied and rectified quickly and responsibly with clear communications from AMCO through its investigator, METRC and the licensee named above.

B. Manifest 93103 is the corrected manifest. On manifest 93104, there are actually two corrections. The first being the time of departure. It should have read 12:26 a.m. instead of 5:26 a.m. The second error should reflect the approximate time of arrival on 8/10/17 as opposed to 8/9/17.

These were accidental input errors on the part of Mr. Fejes as each time one goes back in to METRC to make changes, the times and dates change within the system automatically. Mr. Fejes did not eatch this at that time. He has since become aware of this and it will not occur again.

C. Lastly, the vehicle used on 7/15, 7/17, and 8/4/2017 is owned by Mr, Fejes, Sr. Mr. Fejes Jr. was the operator of the vehicle during the times in question. He was unaware it was not currently registered at the time as it had recently expired. However, the vehicle was fully insured and operated by a licensed driver. In reviewing the applicable regulations as cited by the investigating officer, there is no requirement set forth under 3 AAC 306.750 that the vehicle be currently registered. While this was a mere oversight and not the intent of Mr. Fejes, Jr., the vehicle as set forth above was insured and operated by a licensed driver.

Mr. Fejes, Sr, had simply forgotten to register his vehicle once the license registration had expired. This is not a criminal violation, but a mere infraction under Alaska law. The problem has since been rectified. At all times, however, compliance with METRC and travel manifest were made. All information was input as required including license plate information. It does not ask if the registration is current or not.

In conclusion, it is respectfully requested, that the above violations, not be found, no fine(s) imposed but utilized as a warning, learning tool and held in abeyance within Mr. Fejes' cultivation file. Mr. Fejes, has not, nor would he do anything willful or intentional, to violate any rules set forth within this marijuana industry by the State of Alaska as codified in 3 AAC 306 or other Alaska statutes.

Lastly, Mr. Fejes requests to appear before the Marijuana Control Board and be heard regarding the above violations.

Thank you for your time and attention to this matter. We look forward to working with you in building this marijuana industry.

Good afternoon everyone! I hope everyone's day is going well.

Here at Permafrost we Check inventory daily and I come out to the store twice a week to do an entire audit on what we have available. It came to my attention that we were ~ 20 grams light on one of our package tags, the Frosted Lemonade. I came to a conclusion that the missing amount is weight wasted either by waste (stems and such) and drying. I have also discovered that since the updated way retail stores have to upload each receipt as opposed to entire amounts at the end of each day, and found that our POS system (BioTrack THC) was not reporting our individual sales to METRC correctly. This has been corrected and I do not anticipate further complications due to our POS.

Also moving forward, we will have a better log regarding the waste that we develop and have that updated on a daily basis. As well as I have increased the amount of full audits that I do personally and will be able to better track weight loss due to drying. I will continue to do my best to comply and am happy to have the opportunity to be part of this growing industry in our great state!

While in the store I saw a large sign posted behind the sales counter with information on terpene health benefits. Information on the sign includes the statement, "Terpenes work together with THC, CBD and other cannabinoids to achieve specific health benefits." The sign lists various health benefits including anti-cancer, anti-diabetic, stress relief, anti-inflammatory, nausea relief, brain function, reduced appetite, pain relief, sedative and improved respiration.

This is a violation of 3 AAC 306.360(b)(3):

3AAC 306.360: Restriction on advertising of marijuana and marijuana products

- (b) An advertisement for marijuana or a marijuana product may not contain a statement or illustration that
 - (3) represents that the use of marijuana has curative or therapeutic effects;





On 08/31/17 AMCO Investigators conducted a random audit of your retail inventory in Metrc. The inventory reported in Metrc was incorrect and did not reflect actual quantities on hand. Your POS system Greenbits reflected actual quantities and it was determined that Greenbits had not synced with Metrc for approximately one week. This is a violation of 3 AAC 306.330(c) Marijuana Inventory Tracking System

Upon our entry into your licensed premises it was also observed that marijuana was being processed on a table outside of the restricted access area. This is a violation of 3 AAC 306.710(a) Restricted Access Areas.

I am writing on behalf of my client AK Slow Burn Cannabis Outlet, a Retail Marijuana Store, license number 10245.

AK Slow Burn Cannabis Outlet's licensee, Lou Weaver, received an NOV case number AB17-0460, dated September 18, 2017, stating the following:

On September 11, 2017 an audit was conducted on AK Slow Burn Cannabis Outlet, LLC. During the Audit it was discovered that 1,152 grams of leaf/trim, package tag #1A40203000004B1000000113, Skywalker Trim 19% - 24.99% was received from Enlighten Alaska #10021 – Retail Store. The transfer manifest was signed off for the above amounts by AK Slow Burn Cannabis Outlet, LLC personnel. During the audit of Skywalker Trim 19% - 24% it was discovered the amount in METRC recorded 851.25 grams of Skywalker Trim on site, what was found was 174 grams in pre-rolls, 120 grams of leaf and trim in one storage jar and 350 grams in another storage jar. The total amount was 644 grams, leaving approximately 207.25 grams unaccounted.

Also, there is a discrepancy in the amount of Skywalker Trim 19% - 24.99% that was actually received into the AK Slow Burn facility from Enlighten Alaska. 1,152 grams had been transferred in manifest #0000090914, but what was actually received is unknown as it was admittedly not weighed before the manifest was signed.

The transport received from Enlighten Alaska mentioned above was the very first inventory AK Slow Burn received at their retail store. As you are aware, proper procedures were not followed when that shipment was received by AK Slow Burn employees and was not weighed before the manifest was signed and the transport was accepted into the store and put on shelves for sale. AK Slow Burn is fully aware of and takes full responsibility for the incorrect actions taken in regard to this transport, please see the attached licensee response dated September 13, 2017. New internal policies and procedures have been implemented by AK Slow Burn to prevent this type of violation from occurring in the future, please see the attached licensee response dated October 19, 2017. All future deliveries will include the following steps:

- An AK Slow Burn employee will thoroughly examine the METRC transport manifest and reconcile that document with the product that is physically present
- Each and every product will be weighed and counted by an AK Slow Burn employee and reconciled with the transport manifest, noting any discrepancies
- ONLY when the above steps are completed and the information on the manifest is verified to be correct will the transfer paperwork be signed by the AK Slow Burn employee
- Copies of the invoices and metre paperwork will be photocopied so each party retains a copy and AK Slow Burn will file their copy with their business records

The licensee is confident that the implementation and strict adherence to these procedures will ensure that a similar violation does not occur in the future.

On 9/11/17 we (AK Slow Burn Cannabis Outlet Retail) had a visit from AMCO for our first on site audit. Special Investigator II, James Hoelscher and Special Investigator I, Kendrick Whiteman conducted the audit and want to note they were absolutely professional throughout the audit and answered any and all questions we had. We in return answered all questions honestly and showed them anything they wanted to see.

Three random items of product: 1 Concentrate/Shatter Strain, 1 Pre-Roll Strain and 1 Trim Bulk were randomly picked. We were 100% on two of the three items picked. The Bulk Trim Strain (Skywalker) was found to be 200 grams short. I explained it was part of the first order we received and I had not weighed in the product but had signed for it. Twelve (12) pounds of trim of several Strains had been shipped from Green Leaf out of Sitka to Enlighten Alaska here in Anchorage in May 2017 to hold for us because we and our building were not ready for business. Product was transferred back to us on 8/2/2017, 2 weeks before opening.

I told the Investigators I had no excuse to offer, I was in the wrong for that 1st order being the first day of officially being open and I had not weighed it. I added that from that after that first order, I now have a set procedure in place that when product is delivered, whoever is delivering needs wait till I have physically removed product from whatever package it is in and I weigh it, return it to said package, write down on the METRC Transfer sheet any difference in weight (if any) and then I sign it to accept it.

I give no excuses of what happened to the 200 grams because I honestly don't know outside of the fact the product sat for five (5) months on shelves prior to our business opening. Bottom line is we are at fault for this discrepancy and have a process in place so it does not happen in the future.

- Metric Transfer paperwork is examined next and product is pulled out of delivery container(s) one strain at a time and information on the tags of the bags is verified against the paper work.
- Each product is then physically weighed / counted in front of delivery agent and returned it to bulk package. The weights / counts are written down on the METRC Transfer Sheet noting any difference in weight / count (if any).
- Metric Transfer paperwork is signed after above steps have been completed (NOT BEFORE).
- Delivery agent takes possession of payment and signs receipt showing paid in full.
- 2 Copies of invoices and transfer are made with one set returned with delivery agent to take back to their facility and one copy for our inventory control records.
- Delivery agent signs out and returns visitor badge.

These steps are ensuring we are staying in compliance and that we are signing for correct weights / counts of product.

After our on site training with Kelly Jenkins of Metrc (Oct. 17), we have full understanding of recording waste and have made arrangements with Mr. Jenkins to organize on going webinar trainings direct with him for The Frost Frontier staff. Currently we are working backward from the most current harvest to ensure entries and waste are reported correctly and are working hard to make good progress to ultimately organize past harvest(s); those which are correctable and are able to be finished within the system. We are committed to compliance, track-ability, being well organized and to operate transparently. With that, we are looking to hire a Metric administrator who will be responsible for operating our Metrc inventory system only.

Included in this letter as well, please find a copy of Mr. Jenkins Meeting Summary to us and Ms McConnell at AMCO after the Oct. 17th on site training. Mr. Jenkins discovered outside of the poor start, positive strides have been made moving forward with clear, concise entry applications.

We hope this letter answers any concerns of the AMCO Board and AMCO Enforcement.

Harvests

- Baked Alaska 10-16-17-B
 - Originally, this harvest was accidentally split into two separate harvests when reporting in Metrc. I instructed Beth to waste and then finish these harvests, after which i instructed her to recreate the harvest by creating new plantings and phasing them through the system
- Discussed the process of finishing harvests and ensuring that they are finished with the remaining wet weight (moisture loss)
- Several Harvest batches were recently trimmed and are awaiting the testing process
 - I informed Beth that this product may remain as part of their harvest batch until they are ready to test the product, after which they may package it.

Summary

Overall, the inventory and processes seem to be efficient and accurate. Several harvests were looked into and had to be corrected (listed above) however the rest of the information entered appears accurate and has a well defined model for tracking harvests and plants.

They have also demonstrated clear improvement from entries made 3 months ago in comparison to the most recent entries. Many of the potential errors made in the past seem to have been corrected and i do not see the same issues recurring often if at all
