Standard Cultivation Facility

The board approved this application in June of 2018; the license is currently in delegated status.

Recently we learned that the facility is in the City of Fairbanks, but the licensee stated on their application that the facility was in the Fairbanks North Star Borough, so only the borough was notified by the licensee and AMCO during the application process. This is a violation of 3 AAC 306.025(b)(3)(B).

I recommend that the board rescind your approval of this license and require the applicant to re-notice the application in accordance with 3 AAC 306.025(b) (by posting, publishing, and notifying the local government and the community council). The applicant should be required to submit a new MJ-07, *Public Notice Posting Affidavit*, a new MJ-08, *Local Government Notice Affidavit*, and a new *Publisher's Affidavit*. After receiving these new forms, I will determine the application to be complete under 3 AAC 306.025(d), and send out AMCO's required notices, which will restart the public participation period under 3 AAC 306.065.

Form MJ-08: Local Government Notice Affidavit

What is this form?

A local government notice affidavit is required for all marijuana establishment license applications with a proposed premises that is located within a local government, per 3 AAC 306.025(b)(3). As soon as practical after initiating a new marijuana establishment license application, an applicant must give notice of the application to the public by submitting a copy of the application to the local government and any community council in the area of the proposed licensed premises. For purposes of this notification, the document that must be submitted is the application document produced by the online application system titled "Public Notice".

This form must be completed and submitted to AMCO's main office before any license application will be considered complete.
