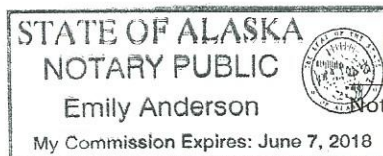

This is a notice to you as licensee that an alleged violation has occurred.
