Please find below a written explanation as to why the following statement cannot be
certified:

“I certify that I have not been issued any notices of violation or committed any civil
violation of AS 04, AS 17.38, or 3 AAC 306 in the previous two calendar years.”

Our client, Smadar Warden, Licensee of Cannabaska License No. 10236 received Notice
of Violation Case No. AB17-0130 on March 28, 2017. The Marijuana Control Board ordered
Mrs. Warden to pay a fine in the amount of \$363.32 at the May 15, 2017 meeting. The fine was
paid in full on May 22, 2017 to AMCO and Mrs. Warden personally assured the board at the
May 15, 2017 meeting that she fully understands the violation and that such violations will not
occur in the future.

Notice of Violation Case No. AB17-0386 was also received by Smadar Warden for License No. 10236 on August 31, 2017. Mrs. Warden and her team have implemented controls to prevent such discrepancies between Metrc and inventory on hand in the future.

This is a notice to you as licensee that an alleged violation has occurred. After reviewing social media, Face Book, it was observed that Alaskasense, aka Cannabaska was advertising a free \$19.00 marijuana cigarette with every purchase of a \$100.00. Upon reviewing your receipts, you did give out three marijuana cigarettes free. This is a violation.

Your attention is referred to 3AAC306.310: Acts prohibited at retail marijuana store

You are directed to respond to the Director of the Marijuana Control Board in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a reoccurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE MARIJUANA CONTROL BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 08/18/17 AMCO Investigators conducted a random audit of marijuana inventory. I selected 3 random packages from your Metrc inventory and compared the reported amounts with the amounts on hand. The following discrepancies were noted with 2 of the 3 packages:

1A4020300001B59000000411 Pineapple X Buds: 57.93g reported in Metrc, 48g on hand

1A4020300001B59000000407 1-nDun F2 buds: 248.43g reported in Metrc, 212g on hand

This is a violation of 3AAC 306.330 Marijuana Inventory Tracking System.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice. 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable law.
