This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 06/05/2018 AMCO Enforcement received information GoodSinse LLC had advertisements for marijuana or marijuana product that did not contain the warnings required pursuant to Alaska Marijuana Regulations posted on Instagram.

I visited the GoodSinse Instagram page, https://www.instagram.com/goodsinse/, and found 74 posts to page. On the main page there were no required warnings posted. I opened each of the 74 posts on the GoodSince Instagram page. Of the 74 posts I discovered 44 of them advertised marijuana or marijuana product and did not contain the required warnings. The posts were date stamped between 03/07/2017 and 12/12/2017.

This is a violation of 3 AAC 306.360. Restriction on advertising of marijuana and marijuana products:

- (e) All advertising for marijuana or any marijuana product must contain each of the following warnings:
- (1) "Marijuana has intoxicating effects and may be habit forming and addictive.";
- (2) "Marijuana impairs concentration, coordination, and judgment. Do not operate a vehicle or machinery under its influence.";
- (3) "There are health risks associated with consumption of marijuana.";
- (4) "For use only by adults twenty-one and older. Keep out of the reach of children.";
- (5) "Marijuana should not be used by women who are pregnant or breast feeding."

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice. 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable law.
