We had our initial inspections on 12-15-16 by Enforcement and the various city departments. We were given small lists of corrections by all departments to complete before our final inspections which were scheduled for today, 12-19-16. 12-16-16 we were unlocked in Metrc and at this time we believed we were within our rights to order product, which we did. We received this product at our facility 12-18-16. We were under the impression that this product would be reviewed by Enforcement during our final inspection. We made no attempt to hide or mislead the inspectors, the product was out in plain view in our secure store room. We followed all regulations for receiving the product. Also, we understood we were not to sell this product until final approvals were granted. Currently, all inspections are complete and we have been instructed by Enforcement to visit the City of Anchorage Admin. office tomorrow morning to collect our final license.

Our understanding of the proper sequence of events for these final stages was that we would have our first round of inspections, get unlocked in Metrc and have a final "product inspection", wherein Enforcement could come back to check off their final items and also make sure we had received our first product shipments correctly. As you may imagine, the last

week and indeed the last few months have been extremely hectic. We have done everything possible to adhere to the regulations set forth by the state and will continue to do so. We did not willfully disregard the rules, this is a misunderstanding and a communication breakdown. We are one of the very first to work through this very complex process and would never intentionally do anything to endanger our position in the market. During our inspection this afternoon Enforcement admitted to me that we never should have been unlocked in Metrc. This was a mistake pure and simple. We were unlocked in Metrc, and acted in good faith and with all the information we had at the time.

Lastly, Dankorage takes full responsibility for this mistake and we are prepared to do whatever is necessary to correct it. Please let me know if you require anything further. Thank you very much for your consideration and we hope you have a happy holidays.
