If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

In the April 5th to April 11th 2018 edition of the Anchorage Press newspaper; Alaska Fireweed did place an advertisement for marijuana and marijuana products in the above mentioned newspaper. The State of Alaska Alcohol & Marijuana Enforcement investigators observed that the advertisement did not contain the required warnings. The five warnings are a requirement in 3 AAC 306.360.

This is a violation of 3 AAC 306.360. Restriction on advertising of marijuana and marijuana products.

- (e) All advertising for marijuana or any marijuana product must contain each of the following warnings:
- (1) "Marijuana has intoxicating effects and may be habit forming and addictive.";
- (2) "Marijuana impairs concentration, coordination, and judgment. Do not operate a vehicle or machinery under its influence.";
- (3) "There are health risks associated with consumption of marijuana.";
- (4) "For use only by adults twenty-one and older. Keep out of the reach of children.";
- (5) "Marijuana should not be used by women who are pregnant or breast feeding."

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice. 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable law



When asked about the visitors log, Nowland admits Pellet is not being signed into the visitor log 100% of the time. Pellet works for NM Enterprise, Inc. and is responsible for selling t-shirts. Pellet has periodically checked ID's at the entrance to the establishment but does not have a handlers permit. Regarding the children on the premises, Nowland stated they were her children and grandchildren. She took them through the restricted access area to gain access to the roof to watch Fur Rondy 2017 fireworks.
