We have worked with Greenbits and METRC to correct the issue resulting in our inventory not being reported. Greenbits is now properly reporting our transactions to METRC. We have adjusted our procedures to confirm that our daily sales have been reported to METRC. We are committed to maintaining healthy working relationships with all our vendors and systems support. Greenbits has been a useful Point-of-Sale tool but they have fallen short on reliability. I apologize for any delays in our reporting due to system issues with Greenbits. I am confident that Greenbits is doing all they can to ensure accurate and timely reporting.

During our first harvest we ran out of work-space for team members to complete their tasks. We have adjusted our work area to allow proper space for employees to complete tasks. By doing a slight rearrangement of our counters we were able to create two more work stations. This was a problem of simply not having enough work space to get through all tasks. Going forward we will plan ahead for enough work space to complete all tasks.

Alaskan Leaf is committed to following all rules and regulations set forth by the MCB and AMCO. We made mistakes that lead to the above two issues. We have improved our systems and processes to make sure that these mistakes will not be repeated. Our staff is dedicated to the highest standard of ethics and compliance. We understand that our marijuana license is a privilege, not a right. Maintaining public trust is important to us and we are embarrassed by the mistakes we made.

This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 08/31/17 AMCO Investigators conducted a random audit of your retail inventory in Metrc. The inventory reported in Metrc was incorrect and did not reflect actual quantities on hand. Your POS system Greenbits reflected actual quantities and it was determined that Greenbits had not synced with Metrc for approximately one week. This is a violation of 3 AAC 306.330(c) Marijuana Inventory Tracking System

Upon our entry into your licensed premises it was also observed that marijuana was being processed on a table outside of the restricted access area. This is a violation of 3 AAC 306.710(a) Restricted Access Areas.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice. 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable law.
