This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 5-29-18 it came to Enforcement's attention True Dank was not reporting sales in METRC since April 5, 2018. I, Investigator Stonecipher went to the Retail Store on 5-31-18 to investigate the incident. It was determined the licensees were using Greenbits Point of Sale system to track sales. Greenbits information was not being uploaded into METRC as required. The licensees admitted they failed to check METRC; as they were relying on Greenbits for inventory tracking. The licensees immediately began to contact METRC and Greenbits support systems to rectify the issue.

This is a violation of 3 AAC 306.330 (a) & (c) Marijuana Tracking System.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice. A licensee may respond, either orally or in writing, to the Notice, 3 AAC 306.810(3)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation from the director, to correct any defect that is the subject of the notice of violation of AS 17.38 or this chapter, a condition or restriction imposed by the board or other applicable

We realize that this could have been caught and resolved a lot earlier if we had been checking METRC sales reports for True Dank instead of relying solely on GreenBits. We will now make it a point to check our METRC sales reports every night to make sure the info is flowing properly.
