What is this form?

This proposed new marijuana product form is required for a marijuana product manufacturing facility licensee who is seeking Marijuana Control Board (MCB) approval of a new marijuana product or marijuana concentrate for production at its licensed premises, as required under 3 AAC 306.100 and 3 AAC 306.525. The required \$250 proposed new marijuana product fee may be made by check, cashier's check, or money order.

This form must be completed and submitted to AMCO's main office <u>prior to production</u> of any new marijuana product or marijuana concentrate. **The proposed new marijuana product may not be produced unless and until the MCB has approved of the product.**

Please note that licensees seeking approval of more than one proposed new marijuana product or marijuana concentrate must submit a separate completed copy of this form and pay a separate fee for <u>each proposed new</u> <u>marijuana product or marijuana concentrate</u>.



Standard Production Procedure and Detailed Manufacturing Process:	Cannabis flower will be rolled or filled into a rolling paper, cone paper, or natural palm wrap and then injected with CO2 extracted cannabis concentrate. The pre-rolled product will be held upright, and the extract injected by hand with a syringe or by a mechanized process. Ratios of flower to oil may vary depending on THC concentrations per batch. Example 1: One Gram of Flower tested at 16% THC results in 160 MG of THC % Gram of CO2 Extracted Cannabis Concentrate tested at 65% THC results in 162.5 MG of THC For a total product THC of 322.5 MG to be reported on the label as such. Example 2: .5 grams Gram of Flower tested at 16% THC results in 80 MG of THC 1/10 of a Gram of CO2 Extracted Cannabis Concentrate tested at 65% THC results in 65 MG of THC For a total product THC of 145 MG to be reported on the label as such.
