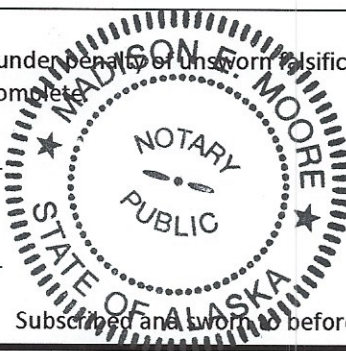

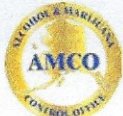

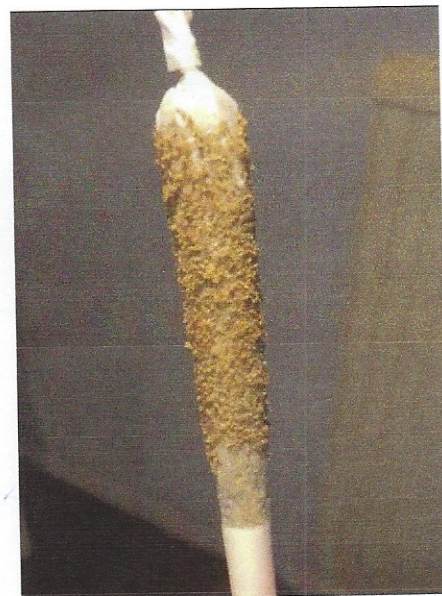
Small = 0.5g gram of flower, one preroll cone, 0.15 gram concentrate wax, and 0.15 gram kief.
Large = 1.0g gram of flower, one preroll cone, 0.30 gram concentrate wax, and 0.30 gram kief

Standard Production Procedure and Detailed Manufacturing Process:

Take preroll cone, tare weight increment on scale, then pack with desired flower amount. Paint the outside of the cone with desired amount of concentrate wax. Roll the painted preroll in desired amount of kief. Stop after each step to verify weight on calibrated scale. Once completed let air dry/harden for a few minutes.

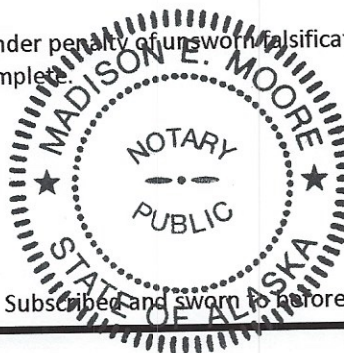

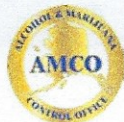

Weigh cannabis to 0.34 grams. Cover the cannabis with .33 grams of concentrate and then roll the concentrate covered cannabis in .33 grams kief until all kief sticks - Stopping after each application to verify weight on calibrated scale.

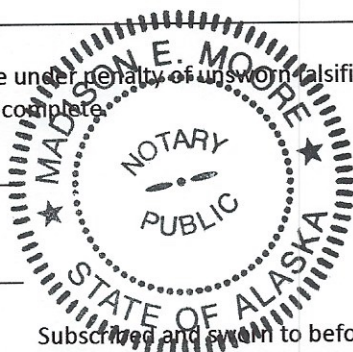



The extracted cannabis oil is then heated in our vacuum ovens at a specific temperature to purge out all residual solvents and to active the cannabinoids. The temperature is increased to decarboxylate the concentrate. Oil is then congregated for testing and stored in large syringes until packaged for sale. There is no expiration date with marijuana concentrates, however, product may alter cannabinoid profile after one years time. Additional testing will occur if that happens.

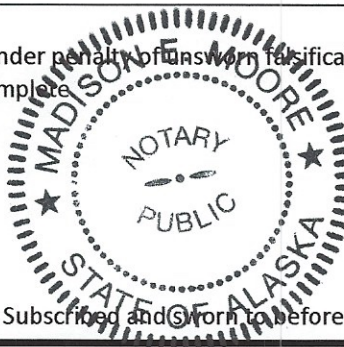



Stir until the sugar is completely dissolved. While mixture is heating, mix desired flavor and desired amount of cannabis concentrate together to emulsify and then wait to mix with the other ingredients. Once sugar/water substance gets to 300 degrees and fully blended remove from heat. As mixture starts to cool, pour the flavor with cannabis concentrate into the mixture and continue to stir until fully homogenized. Carefully pour into candy mold and let cool to harden.
