**Re: Failure to pay taxes under AS 43.61.010 by licensed marijuana cultivation facilities**

Pursuant to Alaska Statutes and Regulations, AS 43.61.030 and 15 AAC 61.020, the Department of Revenue will inform the Marijuana Control Board of licensed cultivators that have failed to pay tax due or file a return as required by law.

As of November 15, 2018, there were 20 licensed cultivation facilities that failed to pay marijuana excise taxes as required under AS 43.61.010 totaling \$392,000. The list below does not include accounts that are currently on payment plans or have past due balances under \$100. If we reported the total number of past due accounts, we would report 32 taxpayers owing a total of \$728,400 – this is 25% of all marijuana taxpayers that owe past due taxes.

The high number of past due accounts is alarming and the Department of Revenue will continue to report the names of the delinquent taxpayers monthly to the Marijuana Control Board through AMCO, excluding the accounts that are currently on payment plans.

On Tuesday, January 22nd 2019 at approximately 10:30 AM, Enforcement Supervisor James Hoelscher and I went to the Cinnabar loop area where Danish Gardens, LLC is located. The wind was gusting to the west of Danish Gardens, LLC. we could easily detect a strong odor of marijuana coming from the standard marijuana cultivation Danish Gardens, LLC. The odor was detected in and around the industrial and residential area of Cinnabar Loop and the neighboring streets.

Please regard this Notice of Violation as AMCO Enforcements directive that Danish Gardens, LLC will ensure that any marijuana or marijuana product at the facility does not emit an odor that is detectable by the public outside of the cultivation facility.

This is a violation of:

3 AAC 306.430. Restricted access area. (c)(2)

(c) A marijuana cultivation facility shall ensure that any marijuana at the marijuana cultivation facility

(2) does not emit an odor that is detectable by the public from outside the cultivation facility except as allowed by a local government conditional use permit process.

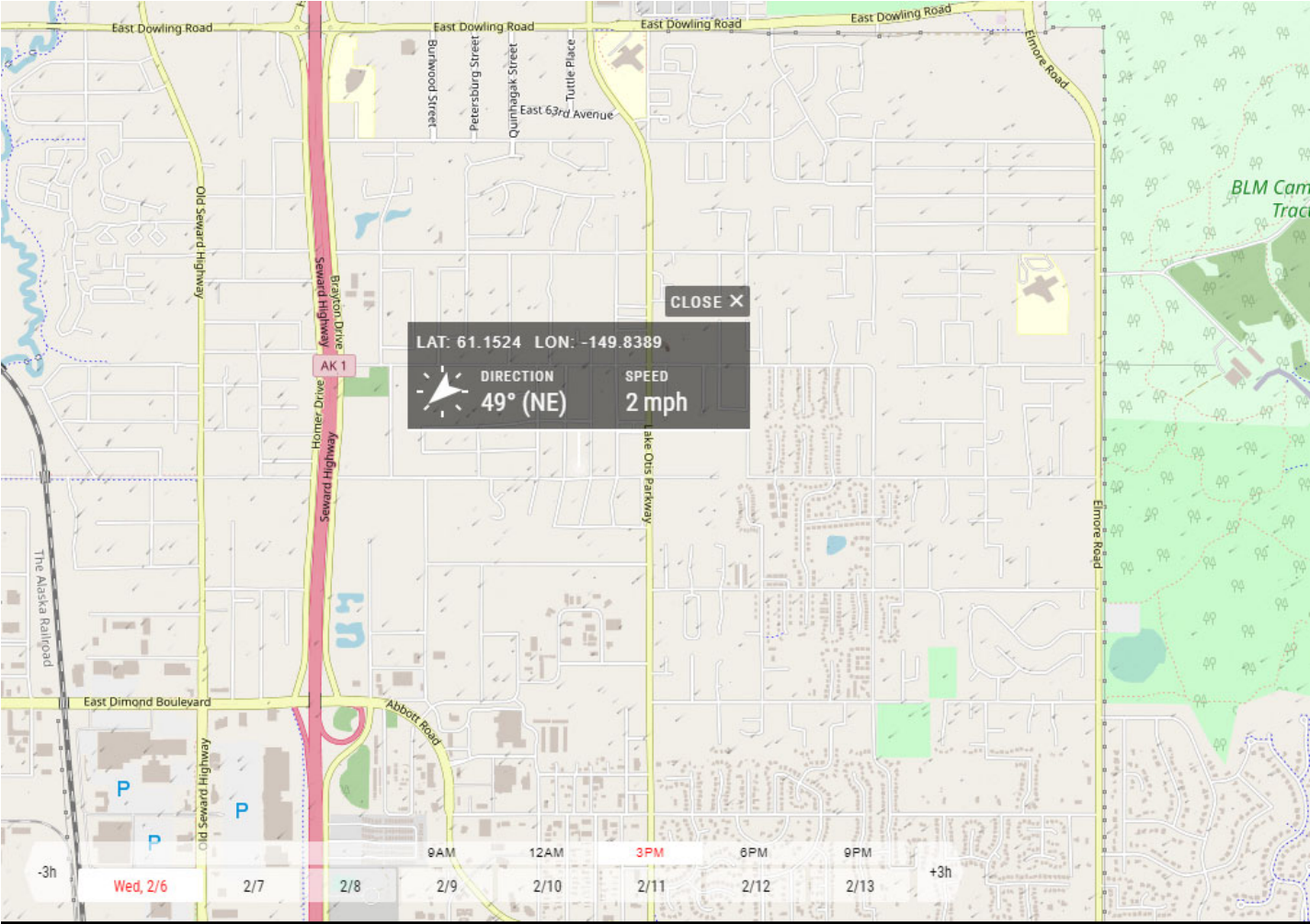

On 6/12/19 I conducted a routine inspection of Danish Gardens. I found the METRC recording to be off for all the rooms. There were 74 plants that were recorded to be in veg room A but were actually in Flower A. Veg room A had 419 plants in it recorded in metrc. There were a large number of plants in the room but only 87 plants scanned as being plants assigned to veg room A. The plants from veg room B were relocated to veg room A but still showed up on metrc as being in B. Of those relocated plants only 8 tags scanned of the 50 that were supposed to be present in veg room B. When scanning flower room A only 1 tag out of 40 scanned, only 8 of 26 tags scanned for the mother room, and only 3 of 86 plants scanned for flower room B. The plants that I viewed were all tagged so this means that the tags are not being assigned in metrc.

These actions are in violation of:

3 AAC 306.435. Marijuana inventory tracking system

(a) A marijuana cultivation facility shall use a marijuana inventory tracking system in compliance with 3 AAC 306.730 to ensure all marijuana propagated, grown, or cultivated on the marijuana cultivation facility's premises is identified and tracked from the time the marijuana is propagated through transfer to another licensed marijuana establishment or destruction.
