Mark Springer asks if anyone is present for any of these items and wishes to have their tab heard at this meeting. None are present via phone or in person. Springer agrees to a telephonic hearing at the call of the chair for these tabs at a later date.

Mark Springer states that he will be taking Brandon Emmett’s place during discussions of possible legislative matters.

### **● PUBLIC TESTIMONY**

**1:11pm**

Public testimony is limited to issues not on this agenda and that are not proposed regulations.

Written comments may also be submitted to the board for review during its next regular meeting via [marijuana@alaska.gov](mailto:marijuana@alaska.gov). The call-in number is 1-800-315-6338, code 69176#.

Cary Carrigan, Executive Director of the Alaska Marijuana Industry Association, is present in person. He provides testimony regarding the marijuana licensing process, and requests the board to allow the discussion of medical marijuana or CBD. He would like to put on record that the board, enforcement, and staff have done an admirable job. He thanks Mr. Emmett for his service on the board. He asks that marijuana not be pushed back into the darkness.

Jana Weltzin, JDW Counsel, discusses the State of Alaska budget proposal. She finds that the AMCO office, enforcement, and their work, to be important and that consolidating power is a disservice to

*Alaskans. She states that what is good for Anchorage may not be good for the outlying communities/ rural economy. She states that the board meetings are vital in order to address the needs of the outlying communities. She finds it Un-Alaskan to remove the power from the communities. She thanks Brandon Emmett for his service to the board and the community.*

*Barret Goodale, Good Cannabis in Fairbanks, testifies regarding the necessary amount of cannabis per harvest batch to be tested. He states that AMCO Enforcement directed Goodale to re-batch into smaller batches of 10 pounds or less. He references Metric's opinion regarding harvest batches, and the fact that there has not been action from AMCO to limit the harvest batch size to 10 pounds. He asks for clarification from the board on the 10 pound limit, and asks that they either inform AMCO staff that they must not enforce a regulation that is not yet in effect, or inform metric of the limit.*

*Mark Springer asks Goodale to forward his concerns to the Director in writing so that they may be forwarded to the board.*

*Brandon Emmett states that there does seem to be an inconsistency, and that the intention in the testing committee was not to make things more difficult. He states that if 12 pounds are harvest there could be a 10 pound harvest and a 2 pound harvest. He states that there may not be enough clarity provided.*

*Mark Springer and Brandon Emmett discuss the current table for harvest batch sizes and testing amounts.*

*Erika McConnell states that this is an issue that AMCO staff is aware of.*

*No one is present at this time to testify via phone.*

*Sam Hachey, Tanana Herb Company, testifies in person about the harvest batch vs testing amount, and harvest batch vs harvest. He references a harvest batch being tested only one time. He suggests that individual packages be tested (flour, trim, etc.).*

*Erika McConnell states that seems to be very close to comment on a current regulation that is to be considered on this agenda.*

*Via phone, David Straub, Alaska Precision, identifies himself. Mark Springer allows the Director to speak. Erika McConnell clarifies that a hearing will be rescheduled for his matter that was previously Tab 8. Regarding matters not on Tab 8, he states that he finds a 30% tax to be too high. He asks the board to address the tax structure, and the testing, and says that testing a small amount is not representative of the product.*

*Lilly Bosshart testifies about the CU1 program, she says that it seems like there are a huge number of caveats regarding the program and it seems like it will be very expensive. She urges caution about participating in the program.*

*Mark Springer thanks Lilly Bosshart for her testimony.*

● **DIRECTOR BRIEFING**

**1:36pm**

**TAB 3**

*Erika McConnell summarizes her report as written in Tab 3. She provides a fact sheet about AMCO's operations that was presented to legislators on Monday, to the board.*

*She states that she has a large work load, and while she tries to respond to inquiries or concerns in a timely manner, there are times where she has not responded and she apologizes for those times. Mark Springer asks about the receipts and the split on receipts to local governments. McConnell confirms that this information is on the AMCO website, and offers to make the other statistics available to the board.*

*Brandon Emmett asks how many hours it takes McConnell in a month to complete the necessary Director activities. McConnell states that it is approximately 10-11 hours per weekday and 1-2 full weekend days a month, and that during board meeting prep weeks its closer to 12-13 hours per weekday and multiple full weekend days. They discuss staff workloads and hours.*

*Mark Springer states that it should be clear to everyone that staff is working very diligently, and thanks staff.*

*Brandon Emmett thanks staff as well and states that based on the numbers, the department pays for itself.*

● **ENFORCEMENT BRIEFING**

**1:54 pm**

*James Hoelscher states that the hours stated by the director are more likely an underestimation of the time she puts in.*

**A. Enforcement Supervisor's Report**

**TAB 4**

*James Hoelscher summarizes his report as written in Tab 4.*

*Harriet Milks notes for the record that interruption of the audio feed is occurring.*

*Mark Springer states that nothing so far has been said that is not in the report.*

*The audio signal has cleared up.*

*James Hoelscher asks the board to clarify where in a licensed premises a licensee must check for proof of age from someone in their establishment. He states that this matter has arisen for enforcement and asks for board clarification on this matter.*

*Springer states that the purpose of showing ID is to prevent individuals under 21 from entering a store. He states that only checking ID at the time of sale could possibly allow someone under 21 to enter the store. His understanding is that ID is checked before someone comes in.*

*Loren Jones states that there have been lots of discussions about licensees needing to follow their operating plan, and that the matter of where an ID check occurs is discussed during the review of operating plans. IDs must be checked at the door. He asks that the operating plans be checked and if licensees are not following their operating plan to check IDs at the door, then a problem has arisen.*

*Nick Miller agrees with Loren Jones. The intent is not to allow individuals under 21 in the stores. He states that he does not believe that the board would approve a license that states that the ID will be checked at the time of sale.*

*Brandon Emmett agrees, and that his operations check IDs at the door.*

*James Hoelscher asks the board about 3 AAC 306.430(c)(2), odor requirements. He states that odor complaints are becoming a large problem and that there are several licenses who have had multiple, repeated complaints lodged against them for these matters.*

*Brandon Emmett states that AMCO should enforce regulations. He states that there are several regulations that were created to prevent problems with bias against the industry. He references the smell of marijuana not harming people, and the eventual normalization of marijuana byproducts (such as smell).*

*Loren Jones states that in his community, odor is addressed in the conditional use permit. He asks that people in the Juneau area bring their complaints to the local government.*

*There are connection problems on the phone line; the phone is restarted.*

*James Hoelscher addresses the board's comments, states that complaints come in waves, and says that sometimes comments have come to enforcement and the board that the odor is a problem. He states that people should be held accountable and that there are multiple cultivators who do NOT have any odor complaints (showing that it is possible to operate without them).*

*James Hoelscher references 3AA 306.770(b) He asks the board if the decals on the doors of establishments are considered advertising and asks what counts toward the three sign limit.*

*Mark Springer addresses the "visible from public thoroughfare", and states that he is not sure.*

*Brandon Emmett states that the interpretation is that it's "large, highly visible advertisements" and he does not find small signs to be a problem.*

*Nick Miller states that the matter of signs was discussed previously, and that if this matter must be discussed again, this matter may need to be revisited. He asks retailers and enforcement to use their "best judgement" in applying the regulation.*

*Mark Springer asks Mr. Hoelscher to hold consideration this matter, and use discretion regarding this matter at this time.*

*James Hoelscher states that the issue must be revisited, even with enforcement exercising their best judgement, and that the matter must be clarified by the board.*

*Mark Springer states that if this is a matter that requires regulatory clarity, a project may be opened.*

*Brandon Emmett states that the question seems to be black and white- do the signs count towards the number authorized? He states that it is his opinion that the smaller signs do not count to the three signs authorized.*

***Brandon Emmett moves to have the practice of having window decals like 'Alaska's Premiere Cannabis Store' or 'cannabis outlet' approved by the board and that these decals don't count towards the three required signs.***

***Nick Miller seconds the motion.***

*James Hoelscher requests to know if the smaller signs, not being counted towards the three sign limit, will count as advertisements.*

*Brandon Emmett states that if there is a picture of marijuana or marijuana product, then it does require the warning statements.*

*Mark Springer states that there may be decals that handle paraphernalia or sales of related items.*

*James Hoelscher states that he does not find it inappropriate to have a decal for paraphernalia / CBD products.*

*Brandon Emmett states that he hoped that CBD was not going to be addressed, that matter is a separate concern.*

*Nick Miller suggests that the advertising committee address this matter.*

*Loren Jones states that he wants to make sure that equitable enforcement of signage rules be considered; he would support reexamining the matter in committee.*

**Mark Springer agrees that the advertising committee should be reconvened.**

*Brandon Emmett states that as a point of order, if the motion is not supported or if he should withdraw his motion, the board should still provide guidance on this matter to Enforcement.*

*Mark Springer states that as situations arise, where there are potential violations, enforcement should document the situation (photographs of the advertisements) in which this question arises so that they may be brought to the committee. He warns the industry not to go hog-wild with their windows/doors. He asks that enforcement hold off on NOV's for this matter unless there is an egregious violation that occurs.*

**Brandon withdraws his motion.**

**Nick Miller seconds the withdrawal.**

*James Hoelscher brings up radio advertisements, asks if the radio advertisement is exempt from the license number being published, and asks if the licensee provides more than the list of information if it's a violation. He references three questions- If a licensee provides the license type and tells people to come to his establishment during a sponsorship, should the warning information be used and how can AMCO know the demographic for the radio advertisement?*

*Mark Springer asks what prompts this question and states that if the ad just says "This news comes from Mark's emporium open from 9-5 Monday-Saturday" he does not find this to be an advertisement that requires the warning. He believes that if the radio ad that just says the name of the business but doesn't promote a particular product it doesn't need to have the warnings or license number.*

*Erika McConnell references 3AAC 306.770(c) which requires the license number and business name to be included.*

*Mark Springer states that the advertising committee might want to discuss the print versus radio advertising.*

*Brandon Emmett states that if it is determined that there are requirements for the ads, there should be a 'grace period' to allow time for compliance (effective date).*

*Mark Springer reminds the industry that the license number must be included but that if cannabis product is not advertised they are not required to include the warning.*

*James Hoelscher asks Harriet Milks about the advertisement warning section that exempts ads, and asks about the word “only” in section 770(b). He references Permafrost Distributors advertisement that has a 30 second advertisement that has multiple things other than the allowed items in their advertisement. He states that the ad includes the following information; information about the owner, the license being one of the first regulated cultivators in the state of Alaska, that prior to licensure they spent a lot of time developing upstanding quality genetics for their garden, the ad urges listeners to ask for their product by name at their local retail store and references their website.*

*Harriet Milks states that Erika McConnell may want to answer this question.*

*Erika McConnell states that when the project was considered, the intent was that if the print ad just had the name and location, the warning signs were not required. There was not a discussion that the license number should not be included. She states further that the intent was if the product was not advertised, the warning signs were not required. The license number was not intended to be excluded from the advertisement.*

*Nick Miller states that there are different types of advertisements, one that says ‘hey I exist’, and one that advertises sales and strain specific information. He states that conversations were had about radio advertisements in the testing committee.*

*Loren Jones states that he finds the radio advertisement that James Hoelscher read previously to be very close to advertisement. He states that if there are rules then they must be enforced and he finds referencing strains and product development, to be close to advertisement.*

*Mark Springer states that he finds it to be close to advertisement as well.*

*Loren Jones states that cultivators can’t sell to individuals anyways. He really finds this to be advertising or very close.*

*Brandon Emmett states that he finds it pretty plain, if the product is referenced, it’s advertising.*

*Mark Springer states that the consensus is that it’s pretty clear that the read advertisement is advertising and warning signs must be used. However, if it’s ‘a here I am come see me’, and the product is not depicted, that it is not an advertisement.*

*James Hoelscher states that he will write an advisory regarding this matter to allow licensees to remedy this matter before NOVs are issued.*

*James Hoelscher discusses standardized scales, and asks the board to reaffirm that the accuracy levels are appropriate. (10 gram variance for wet harvested plants, 1 gram variance for buying or selling, and 0.1 gram or less for sales of an ounce or less of marijuana product)*

*Mark Springer asks if cultivators are packaging small units, and states that if two scales are needed then they’re necessary.*

*James Hoelscher asked if the listed variants are acceptable.*

*Brandon Emmett states that this is still acceptable.*

*Mark Springer reads the summary of enforcement activity from the enforcement pie graph.*

James Hoelscher states that there were many investigations opened this year.

## **B. Notices of Violation Issued and Licensee Responses**

**TAB 5**

James Hoelscher states that none of the NOV's are of particular interest at this time, but then he finds some of these matters concerning. Particularly the waste matters and manifest and delivery. He thanks licensees who self-report but states that at some point, the amount of occurrences needs to be reduced.

Brandon Emmett asks Hoelscher about the NOV's issued for virtual transfers, and how often it is seen; Hoelscher states that it does sometimes arise with licensees multiple times. He states that from the industry perspective, as long as it is not happening all the time, it's okay, but if there is a pattern of mistakes it might rise to the advisory or NOV level.

James Hoelscher states that Enforcement tries to communicate with licensees about what the reason behind the mistake is.

James Hoelscher points out some NOV's regarding in-house quality control, tax delinquency, transporting 7.5 pounds of marijuana which is over the transportation limits and he notes that the transport issue was not addressed by the licensee.

Mark Springer states that communication with enforcement is necessary and ignoring enforcement will not make the NOV go away. He asks about the mold on marijuana product. Hoelscher states that if the product has been approved and/or has passed testing it's up to the licensee to determine how to handle the product. If mold is intentionally sold by a licensee it will be reported and handled.

**● LICENSING BRIEFING**

**A. Records and Licensing Supervisor Report — TAB 11**

*Mikal Milton summarizes Tab 11 the Licensing Report including staff workloads, license statistics and queue length (11 applications).*

*Erika McConnell answers board questions about how to search license applications by status, as available on the website.*

**B. Forms for Onsite Consumption Endorsement — TAB 12**

*Erika McConnell summarizes the documents included in Tab 12, and the purpose for the additional advertising formats and forms. She states that additional minor revisions may occur. She answers board questions regarding local government input.*

*Harriet Milks confirms that the Lieutenant Governor has not signed the onsite consumption regulation at this time.*

*Erika McConnell references the MJ-02 and MJ-14 as being required with an application for onsite consumption but not included in this packet because the revisions occurring to these forms are minor.*

**Loren Jones references that the regulations require a statement on the protection of the worker or employee, and he asks how the business protects the worker and asks that this be included in the form.**

*Loren Jones states that there will need to be changes to the conditional use permit process. He says as a heads up this matter must be addressed.*

*Erika McConnell states that this matter may be addressed during the conditional use permit regulation that will address conditional protests, and she recommends approval.*

**Brandon Emmett moves to approve items in Tab 12 (onsite consumption forms) with delegation to amend the operating plan requirements in the proposed MJ-28b to include employee safety information, and that the application include a section that asks about the consumption method proposed.**

**Loren Jones seconds the motion.**

*Brandon Emmett states that there have been so many issues with smoking when the original project was proposed that the change to include consumption method is necessary.*

*Erika McConnell stated that 306.370 requires the building be freestanding because of smoking but that if edibles are the only things sold, it may have been an inappropriate limitation.*

*Mark Springer asks how hard it would be to engage in a comparison and to determine if there is leeway to allow edibles only in non-freestanding facilities. He states that this is a work in progress and that if there are thoughts on these forms from the industry or local governments that they should be considered.*

**None opposed, motion carries.**

#### **C. Form MJ-20a: Renewal Residency Exception**

**Brandon Emmett moves to approve MJ-20a Renewal Residency Exception.**

*Loren Jones stated that changing from limited to standard will be difficult for many limited cultivation operators who are operating out of their homes.*

*Erika McConnell states that if the location is changed, it will be a new license application and not a conversion.*

### A. Proposed Projects

#### 1. Staff Recommendations

TAB 16

*Erika McConnell summarizes the staff recommendations as listed in Tab 16.*

*Mark Springer asks for a short presentation/informative paper from the other states that have best practices for advertising.*

*Mark Springer asks if the Advertising committee has been formalized or ad-hoc, he then designates Nick Miller as the chair of the advertising community, and asks that he get input from enforcement, the director and licensees.*

*Mark Springer discusses that he spoke with Bob Klein about having a trade show or Marijuana event on a liquor licensed premises, and that the transportation changes should keep in mind that plants/samples may be transported for advertising purposes.*

*Brandon Emmett asks about an "event permit" that was contemplated to go with onsite consumption.*

*Erika McConnell stated that the event permit was a legislative request, and discusses the fact that a new permit or license may not be created by the board.*

**Brandon Emmett moves to open regulation project to make additional changes to the regulations for "Onsite Consumption".**

**Nick Miller seconds the motion.**

*Brandon Emmett states that the regulation should be changed for places without a local government, and the ability to have a non-smoking onsite consumption endorsement.*

**All in favor, none opposed, motion carries.**

**Brandon Emmett moves to open regulations project titled "Packaging and Labeling".**

**Nick Miller seconds the motion.**

*Brandon Emmett states that it is necessary to address the packaging and labeling in relation to other states best practices, particularly in situations such as pre-rolls and other ambiguous situations regarding what is "packaging" a product.*

*Mark Springer states that he wishes to hold effort on staff's part until information is attained on other state's best practices regarding this matter.*

**None opposed, motion carries.**

**Mark Springer states that he would like to *tighten up handler permit revocation, that public notice of revocation will be given, and that the board should consider the revocation of a handler permit at the request of a licensee.***

**Brandon Emmett so moves.**

**Nick Miller seconds the motion.**

**None opposed, motion carries.**

**Brandon Emmett moves to open a regulations project titled "Transportation".**

*Brandon Emmett states that this is particularly important for larger businesses and the businesses that have a larger distribution base. It's important to addressing hubs, driving requirements and finding a way to facilitate commerce. He references a broker or hub license or finding a way to have a license as currently written to operate like a hub. He finds this to currently be a significant risk to public safety and the back flow issue should be addressed.*

**Brandon Emmett moves to open regulations project "Retesting".**

**Nick Miller seconds the motion.**

*Brandon Emmett states that this is an important matter to growers and that it should be at least discussed.*

*Erika McConnell summarizes the information in the Memo and additional documentation in Tab 17 for regulations project “Fine Schedule”.*

*Mark Springer ask if this removes the board’s ability to increase fines.*

*Harriet Milks states that this is guidelines, but that the board still has discretion.*

*Erika McConnell answers board questions regarding licenses transferred before a transfer has been approved.*

*Nick Miller states that the fines and closures for first offenses are very concerning.*

**Brandon Emmett moves to put regulations project “Fine Schedule” out for public comment with the intent to receive robust public comment.**

**Nick Miller seconds the motion and urges people to comment on this regulation.**

**None opposed, motion carries.**

Loren Jones asks why the chair finds this change necessary, he states that sometimes the entities “adopt” the state, and he finds that these entities have their own authority to investigate, and he is unsure that he supports making that change.

Mark Springer and Loren Jones discuss the matter of “state” vs other agencies and who should have authority.

*Harriet Milks clarifies that the Department of Law would read this as the ability by the director or board to reach out to local authorities. She finds it less about the obligations of local authorities but about making sure that licensees and the public understand that the board or director may reach out.*

**Brandon Emmett moves to adopt regulations project “Inspection Parameters”.**  
**Loren Jones seconds the motion.**

*Nick Miller states that he finds the language including “all business operations” to be a bit broad, as related to the public comments received. He cannot support the project as written. He asks that the language be amended to tighten up the language regarding which operations qualify.*

*Loren Jones states that a licensee must follow the operating plan, and that the board should have the right to investigate all matters listed on the operating plan within reason. (eg: where backup or records are kept).*

*Brandon Emmett states that, looking at the comments, there are some strongly opposed to the project and one is strongly for. He finds the difference to be how the company looks at enforcement. He states that he agrees with Great Northern Cannabis. He asks Nick Miller if the motion is withdrawn if there are specific amendments that need to occur to make it reasonable for smaller more spread out operations.*

*Nick Miller states that he has no suggested language but he would like it to be more specific.*

*Loren Jones states that there have been situations in the past where marijuana product was stored outside the premises. He states that he is more worried about product and situations where records or tape is unable to be produced. He is not asking for carte-blanche to walk into living rooms. He would be okay with returning to this matter if stricter parameters are necessary.*

*Nick Miller discusses that there are mechanisms in place to catch ‘bad actors.’*

*Mark Springer discusses the “and the location of other elements of business operations” being the problematic language and asks Harriet Milks how clear this language is.*

*Harriet Milks states that Department of Law would see these elements as “business records and product” but that if the board wishes they could clarify that it is “business records and product” but that it is clear that it is items only relevant to the business records and product.*

*Mark Springer asks if removing this section but retaining “waste disposal areas” is substantive change.*

*Harriet Milks confirms that it would be substantive.*

*Mark Springer discusses the “other elements of business operations” change and states that he would be okay with removing the language.*

**Brandon Emmet withdraws his motion and makes a new motion to send the draft back to staff for revisions with input from Nick Miller.**  
**Nick Miller seconds the motion.**

*Mark Springer states that he would like to hear from enforcement on why they find the language necessary.*

*Mark Springer states that there is minimal public comment in favor of the license fee increases and asks why concentrate only license fees are so low.*

*Brandon Emmett states that the original intent of the concentrate only licenses was to be similar to a "limited grow". He discloses that he has a public Facebook and that he has been flooded with comments and questions regarding this matter but states that he did not respond to them and finds that there is no*

conflict. He finds that small growers are the most impacted by this change and they find it inappropriate that they are getting a 100% increase. He finds that the industry that is generating so much revenue should not be considered to "owe the government money". He is on the fence about if the large cultivation fees should be increased or if the smaller grow fees should be decreased. He would like to hear from the rest of the board regarding this matter.

Mark Springer asks what, given the number of licenses, the revenue impact on the office would be.

Erika McConnell references the December tab for this matter, where she provided a chart that indicated revenue generation increase created by multiple proposals.

Emmett mentioned that the ballpark was 4.5-5 million approximately.

Erika McConnell states that the increase in revenue would be 600 thousand, for a total of slightly over 2 million dollars.

Mark Springer asks if the fees are split with local governments, Erika McConnell confirms that the application fee is split.

Brandon Emmett wishes to hear from the larger growers regarding this matter. He wants to know if the big grows can take more of the proposed burden. He states that ultimately people will be unhappy either way.

**Brandon Emmett moves to send regulations project "License Fees" back out for public comment for an additional 30 days.**

**Nick Miller seconds the motion and asks that the director republish the table as well.**

Loren Jones states that he has a problem for this to go back out for public comment, he finds that logistically this would not provide enough time for the fees to be in place before the renewal process, and he finds that implementing this before the renewal period is important.

Harriet Milks addresses Loren Jones concerns, she states that the idea that the matter needs to go back out for public comment for substantive changes is to protect the public/licensees. Reducing the limited cultivation fees would not require republication but increasing the standard cultivation fees would be considered necessary to go back out for public comment.

Mark Springer and Erika McConnell discuss if budget projections include these revenue increases, and when the fees would go into effect.

Brandon Emmett asks if small grows are reduced to a 1400\$ fee the project would not need to go back out to public comment.

Harriet Milks confirms that it is her opinion that it would not.

**Brandon Emmett withdraws his motion, and moves to change the fee for small cultivators to \$1400 and then adopt the regulations project "License Fees".**

**Nick Miller seconds the motion.**

**None opposed, motion carries.**

It should be considered that sometimes individuals under 21 work on this type of project in universities, and that the university should be consulted more on this matter.*

*Brandon Emmett mentions that the UA system just created its first chemistry of cannabis course and that there is time before this matter needs to be settled.*

**Loren Jones moves to send the project back to staff and volunteers to be part of the discussion, with the caveat that this is not a pressing matter and the intent to discuss this matter with the board volunteers and possibly qualifying universities.**

*Erika McConnell confirms that the board wishes to send the project back, to allow for multiple licenses with a focus on research and development, and that the board wishes to possibly reach out to the universities and receive input regarding their opinion(s) on this matter.*

Brandon Emmett states that overall he supports the license, and that this application directly speaks to the issue of hubbing for package and storage that has arisen within the industry. He does find issue with collection of kief for repackaging; that is manufacturing, and if it is a by-product of trimming, it goes back into the marijuana. The kief would need to go back into the product it fell out of.

*Harriet Milks confirms Brandon Emmett's interpretation of the rules related to kief.*

*Applicant and counsel discuss what would be available for inspection in Phase 1, that only the phase one space would be built during the inspection phase, and confirmed a premises diagram change would be submitted when phase 2 was ready.*

*Erika McConnell states (for the board's information) that the form changes ask applicants to include all phases of construction.*
