Staff Updates and Workloads

We currently have two dedicated marijuana occupational licensing examiners: Jane Sawyer and Jacqlene Drulis. TJ Zielinski continues to process both alcohol and marijuana applications.

Alcohol License Renewal Applications

Since our office sent out 906 renewal applications, we have received approximately 835 applications, which is about 92% of the licenses due to renew this year.

Marijuana License Renewal Applications

This is a reminder that all licenses in Active-Operating status on or before June 30, 2019 **must** renew their license no later than July 1, 2019. The renewal notices required by 3 AAC 306.035(a) will be sent out on May 1, 2019.

<u>Timeline for New/Transfer Applications on This Agenda</u>

The following applications are listed in the order in which they were placed into the queue.

The average time it has taken for the applicant to receive an incomplete letter from the licensing team, from the date that the application went into the queue, is 46 days (1.5 months) for new applications and 3 days for transfer applications. These numbers are down from my February 2019 report which stated that it took 114 days (3.8 months) for new applications and 37 days (1.2 months) for transfer applications to receive their incomplete letters.

The average time it has taken for the applications on this agenda to be determined complete, from the date that they went into the queue, is 77 days (2.6 months) for new applications and 22 days for transfer applications. The time for new applications is down from my February 2019 report which showed that it took 161 days (5.4 months) before an application was deemed complete. The time for transfer applications is down this reporting period from 111 days (3 months) as listed on my February 2019 report.

At this time the "to be reviewed" queue for Marijuana establishment applications has 9 applications waiting for review. Our team has been working diligently to reduce wait times and will continue to do so.
