

Product Description: Details must include the color, shape, and texture.	Glacier Fire Logs will be circular and round (cylinder) in shape. Glacier Fire Logs will be 4 to 5" in length, Glacier Fire Logs will be between 1/4" to 1/2" in circular diameter. Glacier Fire Logs will be brown/green/purple in color dependent on which palm leaf or leaf wrap is selected. Glacier Fire Logs will look similar to a Cigar and have the texture and feel of paper and or palm leaf paper.
Ingredients:	Marijuana , marijuana concentrate (either Glacier Extracts approved Glacier Goo [concentrate CO2 oil], Glacier Extracts approved product Glacier Vape Pen Oil [concentrate CO2 oil], or another locally-sourced, lab tested AMCO-approved manufacturer's marijuana concentrate). Kief/Bubble Hash (either Glacier Extracts approved kief/bubble hash or another locally-sourced, lab tested AMCO-approved manufacturer's marijuana concentrate).
Standard Production Procedure and Detailed Manufacturing Process:	2 to 3 grams of marijuana will be placed into a standard manual rolling machine. Starting with 1 gram to 1.5 grams of marijuana (add into rolling machine). Once rolling machine is filled with 1/2 the total amount of marijuana, next we add a 1/4 gram to 1/2 gram of Concentrate CO2 oil. After oil is added to marijuana in rolling machine, next we add a 1/4 gram to 1/2 gram of Kief or Bubble Hash to rolling machine. After oil and kief/bubble hash has been added we will top off the rolling machine with 1 gram to 1 1/2 grams more of marijuana to make 2-3 total grams of marijuana. Next we will close rolling machine and insert a palm leaf/hemp wrap, after rolled, wraps will be sealed with moistened Sponge.



Product Description: Details must include the color, shape, and texture.	Glacier Extracts Firestick (marijuana-infused pre-roll) will look the same as a standard marijuana pre-roll. Long and thin, with a filter at one end, Material of pre-roll will be made of Palm Leaf (palm leaf will be used in place of standard paper to help withstand saturation caused by papers natural absorbtion to oil). Palm leafs color is natual and that of light brown and light green. Texture will be smooth with raised veins (natural leaf texture).
Ingredients:	Marijuana, marijuana concentrate (either Glacier Extracts approved product Glacier Goo [concentrate CO2 oil], Glacier Extracts approved product Glacier Vape Pen Oil [concentrate CO2 oil], or another locally-sourced, lab-tested AMCO-approved manufacturer's marijuana concentrate).
Standard Production Procedure and Detailed Manufacturing Process:	Create a standard pre-roll using palm leaf. Prior to closing pre-roll, a thin precise needle with a specific and consistant amount of marijuana concentrate will be inserted directly down the center of the pre-roll, slowly injecting a microdose of marijuana concentrate as it withdrawls.
