This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

It has come to the attention of AMCO that some marijuana retail establishments have been consuming marijuana product for "In-house quality control." This conduct is only permitted for cultivation and product manufacturing facility license types per Alaska Regulation.

Glacier Valley Shop has made 205 package adjustments for in-house quality control. Grace Doubrava stated that the Glacier Valley Shop "samples out to employees" the contents from their sniff jars and small amounts of unsellable product. See attached Metrc Spreadsheet.

This is in violation of 3 AAC 306.310(b)(3)(A)

Please note that in: 3 AAC 306.460. Samples (d), 3 AAC306.557 Quality control sampling, those actions are only allowed for cultivation and product manufacturing license types.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.

To whom it may concern:

This letter is in response to the Notice of Violation received via email on December 5, 2018 for License #13217 for ForgetMeNot Enterprises Inc dba Glacier Valley shop.

It was never our intention to violate 3 AAC 306.310(b)(3)(A). The violation was a result of a misreading of the regulation. Specifically, the section of Quality control sampling. It was our understanding that, for the purposes of training, we could provide samples to our bud tenders, as its budtenders who are the ones who will be speaking directly with the customers. It makes logical sense that a budtender would be included in the allowance of quality samples, otherwise how do they sell the product and describe the characteristics to the customers? By providing samples to our budtenders they are able to familiarize themselves with the different strains and their respective qualities in order to more effectively sell the product. We did not realize that the sampling was only allowed for employees in cultivation and manufacturing. We only sampled out product from our sniff jars or small amounts of otherwise unsellable product. We required our employees to complete an MJ 26 for every sample given when that requirement was mandated. It was our error completely. This practice has ceased and will not occur again. Going forward all product in sample jars will be packaged, discounted and sold or wasted out and destroyed if it is deemed unsellable.

Again, it was never the intent of Glacier Valley Shop to willfully violate 3 AAC 306.310(b)(3)(A), we had diligently listened to the MCB hearing in November 2017 when this was discussed and approved, and we recall the discussion between the board members to include the benefits of allowing this type of quality sampling for budtenders as well.

Regardless, we recorded all adjustment in METRC and required MJ 26's be completed for every sample given. We will ensure that this violation does not reoccur by discontinuing the practice. Please feel free to contact me if you have any questions or concerns regarding this response. Thank you.
