I am writing on behalf of Cold Creek Extracts (Lic # 15594) in response to the 1/23/19 NOV issued to Cold Creek Extracts for AMCO Case # AM190138.

On January 17, The Connoisseur (a licensed marijuana cultivator) transferred to Cold Creek Extracts a package of marijuana exceeding five pounds. Cold Creek Extracts accepted the transfer but did not discover the weight discrepancy until several days later. This was an oversight on Cold Creek's behalf. Cold Creek did not immediately realize that the initiator of the transfer had combined multiple production batches into one package for transport and had assigned a single Metrc tracking number.

Cold Creek self-reported this error and requested guidance on how to proceed. Because this was a mistake made with no intent to evade the regulations and because the licensee self-reported, Cold Creek believes that no further action is warranted with respect to this NOV.

I am writing on behalf of Cold Creek Extracts (Lic. # 15594). This message is in response to the NOV issued to Cold Creek on October 12, 2018 (AMCO Case # AB18001257).

Cold Creek acknowledges that an error was made in reporting its waste disposal, and by this email message, Cold Creek Extracts provides additional explanation and context to clarify any confusion.

Cold Creek's Operating Plan provides that all post-extraction waste material will be held in storage receptacles. This waste material, sometimes referred to as "spent marijuana," could include marijuana that has been through the extraction process, materials used in the extraction process (such as ethanol), or infused marijuana oil that does not meet specifications. At least three days prior to disposing of this waste material, Cold Creek will notify AMCO of its intent to dispose of the material and then render it unusable by adding an equal amount of approved non-marijuana substances to the waste material.

Here, as explained in a previous emails between the Licensee and Enforcement, on 10/2/18, Cold Creek decided to "waste" approximately 124 servings worth of infused MCT oil and listed that on its internal waste log on 10/2 (Cold Creek did not waste 124 completed capsules, just the oil that was to be used for those capsules). At that time, Cold Creek added the oil to a waste bin that contained other spent marijuana product material. On this point the NOV allegation is inaccurate. The NOV states that "Cold Creek physically wasted and rendered unusable" the oil. But Cold Creek's action of adding the oil to a bin of other spent material did not render it unusable per the regulations. Cold Creek mistakenly referred to this process as rendering the MCT oil unusable, but that is not what happened. Cold Creek acknowledges that its actions and incorrect use of terminology caused confusion.

On 10/10/18, Cold Creek created the waste entry in Metrc. However, the waste was not actually destroyed or rendered unusable prior to giving AMCO notice. On 10/10/18 Cold Creek provided notice to AMCO that it would render the waste unusable, but between 10/2 and 10/10, the oil was located in a waste bin on the premises. Thus Cold Creek's 10/10/18 notice should have been sufficient notice of intent to waste product and render it unusable. The material was not rendered unusable until five days later, on 10/15/18.

There was no bad intent here, but there were errors in managing and recording waste. The licensee has spent additional time reviewing the regulations and internal operating procedures and has retrained all employees on proper waste management and reporting procedures. Given that there was no improper intent, there was no material that was rendered unusable prior to giving notice to AMCO, and because the licensee self-reported, we believe no further action on this NOV is warranted. Cold Creek Extracts (License #15594) hereby responds to the allegations contained in the NOV issued on 1/31/19 for AMCO Case #AM190203.

The licensee acknowledges that there were errors made with respect to the creation and testing of Alaskan Rescue Balm package *203. AMCO Enforcement and the Director spent significant time researching the issues presented and engaging with the licensee in order to correctly identify the problem and correct the mistake. This was a complicated and confusing case, and the Licensee appreciates AMCO's willingness to work through and understanding of the problem and to come to a resolution.

However, the licensee notes that because this was a factually complicated matter, the NOV provides a statement that licensee believes is inaccurate and could be misunderstood. The NOV states: "The MJ-05 for Cold Creek Extracts indicates that all products will be created from a parent package of "Full Extract Ethanol Hash Oil." This approved process was not followed for the above packages." The issue is that the original MJ-05 submitted by Cold Creek Extracts does not state that all products will be created from Full Extract Ethanol Hash Oil. Rather, Full Extract Ethanol Hash Oil was the sole ingredient listed for marijuana concentrates such as Sugar Wax and Shatter, but other products varied. And Alaskan Rescue Balm, the product at issue, was not listed on the original MJ-05. Alaskan Rescue Balm was first approved via form MJ-16 in August 2018. That form states that the product will contain "marijuana concentrate" which includes "one produced by Cold Creek Extracts, such as full extract ethanol hash oil, shatter, sugar wax, or distillate." Thus, the relevant package of Alaskan Rescue Balm was ultimately created out of shatter and sugar wax, both of which it was authorized to use to create the product.

Further, the NOV could be read to infer that Cold Creek Extracts physically prepared a batch of Canna Caps and then pulled them apart in order to convert them into Alaskan Rescue Balm. This is not what happened. In correspondence on this issue, AMCO acknowledged that this was not a situation where a licensee physically made a product out of another product, but this was a situation where a product was virtually made in Metrc out of another product, and that was a significant Metrc reporting error. As a result, a lengthy administrative hold was place on the product while the error could be investigated and corrected.

In conclusion, we believe the nature of the violation is misrepresented in the NOV. Licensee does not believe this should be treated as a violation of 3 AAC 306.525 (Approval of concentrates and marijuana products) because licensee did not create an un-approved product. If anything, this could be classified as a violation of 3 AAC 306.540 (Marijuana inventory tracking system), as errors were made in using Metrc to report how the product was developed and tested. The mistakes that were made as part of the research and development process, and the subsequent regulatory confusion, ultimately helped the licensee to refine its processes and avoid similar subsequent mistakes.

Since this matter was resolved through cooperation between the licensee, Enforcement, and the Director, and because the product was subject to a lengthy administrative hold, licensee does not believe any further punitive action is warranted in this case.


