

Standard Production Procedure and Detailed	Put cannabis butter in mixer and add peanut butter, graham cracker crumbs, powdered sugar and vanilla. Mix to incorporate. Divide and cover in chocolate. Weigh and enter into METRC. Collect random samples for testing. Enter weight in METRC. Submit for testing
Manufacturing Process:	Place in a numbered and labeled container and store in secure storage room to await testing results. To fulfill an order, move product into packaging room. Take appropriate amount of packages out and fill in Production number and Batch number. Put appropriate stickers on package noting strain dominance and testing information. Fill in product "Best by:" date. Set aside. Put appropriate amount of product on the scale, write weight on package, then put product into package and close. Repeat process for remaining packages in retailer's order. Return remaining product to secure storage. Heat seal filled packages. Place order into bin and return to secure storage. Keep in secure storage until readied for transport



Standard Production Procedure and Detailed Manufacturing Process:	In a large sauce pan, add cannabis tincture, flavoring, sweetener and water. Heat and stir with whisk. Heat until boiling, stirring and cooking for 5-10 minutes. Pour into oiled pans. Cool completely. Cut with portion tool. Put gummies in a large bowl and pour enough oil mixture in to lightly coat. Bag up gummies. Take random samples for testing. Enter weight in METRC. Submit for testing. Place in a numbered and labeled container and store in secure storage room to await testing results. To fulfill an order, move product into packaging room. Take appropriate amount of packages out and fill in Production number and Batch number. Put appropriate stickers on package noting strain dominance and testing information. Fill in product "Best by:" date. Set aside. Put appropriate amount of product into packages. Repeat process for remaining packages in retailer's order. Return remaining product to secure storage. Heat seal filled packages. Place a METRC RDIF label on each package and enter into tracking system. Place order into bin and return to secure storage. Keep in secure storage until readied for transport.
