The course curriculum must cover at least the following topics:

- AS 17.37, AS17.38, and 3 AAC 306
- The effects of consumption of marijuana and marijuana products
- How to identify a person impaired by consumption of marijuana
- How to determine valid identification
- How to intervene to prevent unlawful marijuana consumption
- The penalty for an unlawful act by a licensee, an employee, or an agent of a marijuana establishment
- A written test, demonstrating that each student has learned the information correctly

This form must be submitted to AMCO's main office, along with copies of the course curriculum, before any marijuana handler education course provider application will be considered by the board.

(Marijuana Handler Permits are Public Record)

Please note that a marijuana establishment and each licensee, employee, or agent of the marijuana establishment who sells, cultivates, manufactures, tests, or transports marijuana or a marijuana product, or who checks the identification of a consumer or visitor, must obtain a marijuana handler permit from the board *before* being licensed or beginning employment at a marijuana establishment, per 3 AAC 306.700.

This course is optimized; meaning that it can be taken on a laptop, desktop or handheld device for your convenience. The Firefox browser works best

but it is not a requirement. After completion of the assessment you will be directed to a secure link (a page will pop up which allows you to print or share your achievement /certificate):

 Currently under indictment for an offense listed above.

# Welcome to the Alaska Marijuana Institutes Handler Certification Course

The Alaska Marijuana Institute's online course allows the student flexibility, with quizzes at the end of each module and a 40 (forty) question assessment upon completion. You must have a passing score of 85% to receive your certification (34 correct answers). You may take the assessment 2 times and you may access the reference material during the assessment. # Marijuana Industry Regulation, 3AAC 306 and Enforcement: Civil Penalties

- Overview and in depth study of the regulation of the marijuana Industry

# The following topics (modules) contain basic knowledge required to become a marijuana handler:

- The effects of consumption of marijuana and marijuana products.
- How to identify a person impaired by consumption of marijuana.
- How to determine valid identification
- How to intervene to prevent unlawful marijuana consumption

## The following rules are standard and common practice in the industry:

Understand how to abide by sanitary handling practices which include:

- 1. The use of protective hand coverings when handling marijuana.
- 2. Individual facility sanitary handling practices.

Learn the purchase limits per person:

A licensed retail store may not sell in one transaction more than:

- 1. one ounce of useable marijuana.
- 2. more than seven grams of marijuana concentrate for inhalation, or marijuana or marijuana products if the total amount of marijuana sold contains more than **5,600 milligrams of THC**. b) These limits include marijuana or marijuana product sold for onsite consumption.

Know the rules that apply to a walkthrough in a "Restricted access area":

1. An employee or licensee may not escort more than 5 guests (21 years of age and over) into a restricted access area at one time.

The following list of the most *common* vocabulary words used in the industry will be beneficial to your understanding of the course content:

**Director**-means the director of the Marijuana Control Board and the Alcohol and Beverage Control Board.

**Delivering-**Handing a person who purchases the product on licensed premises only. Does not mean transporting to a person off premises. **Opaque**, resealable, child-proof packaging- A package that is not able to be seen through, can be sealed after opening, and is considerably difficult for a 5 year old to open. All exit packaging must be opaque, resealable and child proof packaging.

**Batch**- A specifically identified quantity of useable marijuana product that is uniform in strain, cultivation conditions, medium, and is harvested at the same time. A batch may not exceed 50 plants. **Marijuana tracking system**-A system prescribed by the board that is capable of sharing with the state a record of all marijuana cultivated and sold, and all marijuana products for consumption, from seed to sale.

**In public**-A place to which the public or a substantial group of people have access to.

**Bud and Flower**-The hairy, sticky, or crystal covered parts of mature female marijuana plants.

**Concentrate-Resin**, oil, wax, or any other substance produced by extracting cannabinoids from marijuana plant

**Consumer-**An individual who purchases and uses marijuana or marijuana product.

Edible-A product intended on being consumed orally.

**Licensed Premises**- All designated portions of a building or structure at the specific address for which an establishment license is issued.

**Lot or "production lot"** means a group of marijuana products that were prepared at the same time from the *same batch of marijuana*, using the same recipe or process.

**Infused product**-A product that contains marijuana or marijuana concentrate and is intended for human use.

"marijuana consumption area" means a designated area within the licensed premises of a retail marijuana store that holds a valid onsite consumption endorsement, where marijuana and marijuana products, excluding marijuana concentrates, may be consumed.

**CBD** means cannabidiol;

CBDA means CBD Acid;

**CBN** means cannabinol;

**THC** means tetrahydrocannabinol, the main psychoactive substance found in marijuana;

THCA means THC Acid

Total CBD" means the sum of CBD and (0.877)\*(CBDA)

Total THC" means the sum of THC and (0.877)\*(THCA)

## Medical Marijuana AS 17.37-developing an understanding to better serve your consumer.

The following will assist you in understanding the identification card and the registry.

- 1. A registry identification card is not valid if the card has been altered, mutilated in a way that impairs its legibility, or laminated. A copy of a registry identification card is not valid.
- 2. The medical marijuana registry includes the name of the patient's primary and alternate caregiver if designated by the patient (access to this list is limited, see #5)
- 3. A primary or alternate caregiver and patient may not possess in the aggregate more than one ounce of marijuana in usable form and six marijuana plants, with no more than three mature and flowering plants producing

## Medical Marijuana AS 17.37

- 4. Medical marijuana is addressed under a specific law; AS 17.37.
- **5. Who has access to the confidential registry?** Peace Officers and authorized employees of the state or municipal law enforcement agencies have access to the registry that consists of patients who have applied for and hold a registry identification card.
- 6. The patient that uses Medical Marijuana must have a physician's statement, stating that the patient has been diagnosed with a debilitating medical condition in order to acquire the card.
- 7. The Primary or alternate caregiver must be at least 21 years of age and never convicted of a felony charge.

## Medical Marijuana AS 17.37

- 8. A person may not apply for a registry identification card more than once every six months.
- 9. Nothing in this chapter requires any accommodation of any medical use of marijuana. in any place of employment;
- ✓in any correctional facility, medical facility, or facility monitored by the department or the Department of Administration;
- ✓on or within 500 feet of school grounds;
- ✓at or within 500 feet of a recreation or youth center;
- ✓ or on a school bus.

## Medical Marijuana AS 17.37

- 10. The medical marijuana card must be renewed annually (check the expiration date).
- 11. The medical marijuana card must be relinquished if the medical condition no longer exist.

- cancer
- glaucoma
- positive for HIV or AIDS
- cachexia (which is weakness or wasting of the body due to severe chronic illness)
- severe pain and/ or nausea, seizures (some of which may be caused by epilepsy), or persistent muscle spasms, like multiple sclerosis.

While a doctor may prescribe marijuana; people in the marijuana industry in Alaska that work in the industry should not claim it has health benefits.

## Recreational Marijuana AS 17.38

AS 17.38 is the ballot measure that lays the framework for the regulation of marijuana in the State of Alaska. (You can read AS 17.38 by clicking on the attachment in this module). The ballot measure allows the State to tax and regulate the production, sale, and use of marijuana. The people of Alaska voted in support of this measure.

Ballot Measure 2- AS 17.38

- Alaskans Voted on 11/04/2014
- Alaskans find and declare that the use of marijuana should be legal for persons 21 years of age or older (ballot measure 2).

- AMCO
- 1. Individuals will have to show proof of age before purchasing marijuana.
- 2. Legitimate, taxpaying business people, and not criminal actors, will conduct sales of Marijuana.
- 3. Marijuana sold by regulated businesses will be labeled and subject to additional regulations to ensure that consumers are informed and protected.

The Law states that personal use of marijuana-is only for individuals over the age of 21(adults), they may:

- 4. Transfer one ounce of marijuana or less.
- 5. Possess, grow, process, or transport no more than six marijuana plants, with three or fewer being mature, flowering plants. (the law goes on to state: not more than 12 marijuana plants, with 6 or fewer being mature, flowering plants may be present in a *single dwelling* regardless of the number of adults 21 and over that may reside in the dwelling.
- 6. A person who violates this section and is found guilty could be fined up to \$750.00.

- 7. If a person presents you with false identification (know the penalty): A person who violates this section is guilty of a violation punishable by a fine of up to \$400.
- 8. Marijuana and marijuana products may not be displayed in a manner that is visible to the general public from a public right of way without binoculars, aircraft, or other optical aids. There must also be reasonable precautions to secure unauthorized access, such as a locked door. The person must also either own the property or have permission from the property owner in order to grow there. If there are any violations of these rules, the fines can be up to \$750.
- 9. It is unlawful to consume marijuana in public, A person who violates this section is guilty of a violation punishable by a fine of up to \$100.

- 1. The Marijuana Industry in Alaska is regulated by the Marijuana Control Board, the governor appoints a director and 5 board members. they serve 3 year terms, staggered.
- 2. The Board controls the cultivation, manufacture and sale of marijuana in the state of Alaska.
- Marijuana establishments and the books and records maintained and created are subject to inspection by the board.
- Local government (which means the; city you reside in, town, village or borough) may establish civil penalties for violation of an ordinance or regulation governing the time, place, and manner of a marijuana establishment that may operate in such local government.

## Marijuana is taxed, and this is how it is done:

\*Marijuana tax rates were changed in January of 2019 and explained in a special section at the beginning of this module.

Effective Jan. 1, 2019, sales and transfers of marijuana are subject to new tax rates.

Mature bud/flower are taxed at \$50 per ounce;

Immature or abnormal bud is taxed at \$25 per ounce;

Trim is taxed at \$15 per ounce; and clones are taxed at a flat rate of \$1 per clone.

- 1. Delinquent payments under this chapter shall subject the marijuana cultivation facility to civil penalties.
- 2. If a marijuana cultivation facility fails to pay the tax to the state the marijuana cultivation facility's license may be revoked.
- 3. Landlords in the State of Alaska are now protected under Ballot Measure
- 2; they may lease or allow the use of property by a person, corporation, or other entity for the cultivation, manufacturing, testing, or sale of cannabis and its products.

## Regulation of Marijuana 3 AAC 306 Enforcement; Civil Penalties 3 AAC 306.800-306.850



The following information applies to the regulation of the marijuana Industry *not* personal use of marijuana. If you work in the field, you must have a handler permit and abide by the regulations set forth by the Alaska Marijuana Control Board. Everything starts with the Marijuana Handler Permit.

Who needs a Handler Permit?

- an owner or licensee of marijuana facility or establishment
- an employee that works at any marijuana facility
- any agent of a marijuana facility
- a budtender, trimmer or janitor
- anyone and everyone who is involved with the
- sale, manufacturing, testing, or cultivation of marijuana

## Licensing & Fees 3 AAC 306.005 - 3AAC 306.100

There are 4 types of license regulated by the Marijuana Control Board; the Board must approve each application prior to operation, the following slide presentation gives you information concerning fees, licensing and some of the regulations that apply to each facility, endorsements (expand boundaries or activities allowed on premises) and are additions to specific license:

- 1. Cultivation facility (Limited and Standard)
- 2. Manufacturing facility
- 3. Retail Facility
- 4. Testing facility

If you are applying for a license- a new application, transferring an existing application to a new person or location, or if you are adding an endorsement such as *on site consumption* to a retail license the cost is \$1000.

The cost to *renew* an application is \$600. If the application is late an additional \$1000 fine assessed.

If the business only wants a minor change, the cost is \$250;

- name of the business
- submit a new diagram of their premise layout
- a new operating plan,
- introduction of a new product,

<sup>\*</sup>Fees are non-refundable Not everyone in the industry will be concerned about fees, but this will give you an idea of what the owner/owners must do to obtain a license or licenses.

# Licensing & Fees 3 AAC 306.005 - 3AAC 306.100 (continued)

- 1. The board will not issue a marijuana establishment license if the licensed premises will be located within 500 feet of a school, a recreation or youth center, a building in which religious services are regularly conducted, or a correctional facility.
- 2. Any owner(of any type of business model) and of any type of facility or Marijuana establishment MUST be a resident of the State of Alaska.
- \*\*It is important (required) that the licensed marijuana establishment operate in accordance with the operating plan approved by the board. The licensee may request an operating plan change in accordance with 3 AAC 306.100 (703)

(continued-detailed information on slide 4)

- 3. An applicant for a new marijuana establishment license must file an application on a form the board prescribes, online and include *a fingerprint card*.
- 4. The non-refundable application fee for a new marijuana establishment license or an application to transfer a license to another person is \$1000.
- 5. Renewal, transfer, or relocation of a licensed premise must be approved by the MCB.

Local Option 3 AAC 306.200:

If a local government's assembly or city council passes an ordinance to opt-out, they can choose not to participate. ALWAYS CHECK LOCAL LAWS

Annual licensing and application fees differ.

Licensing fees are due when the application is submitted and renewal fees are more than the initial year fees for licenses (this doesn't apply to the average "person over 21" working in the field).

Licensing fee list:

Limited cultivation New is \$1000, Renewal is \$1400

Testing or concentrate only facility New is \$1000 and Renewal is \$2000

The following establishments/facilities fees are New \$5000 and Renewal is \$7000 annually.

- Unlimited cultivation facility's
- Retail establishments
- Manufacturers

All license fees are refundable IF the license is **denied**. Additional fees are accrued by a business if they do not pay their taxes on time.

## 1-Marijuana Cultivation Facilities 3 AAC 306.400 - 3AAC 306.480

There are two types of Cultivators license:

- 1.Standard
- 2.Limited-must not be more than 500 square feet of plant canopy space. A Limited facility is permitted to be located inside the home.

### **Requirements:**

- 1. Applicable state and *local* health and safety codes must be adhered to.
- 2. Marijuana product from a cultivation facility can only be sold to another licensed cultivation facility, manufacturing or retail facility.
- 3. Use of the "Seed-to -sell" marijuana tracking system prescribed by the MCB is required, which makes sharing information with the State possible.
- 4. Approved batch testing is required prior to sale on all product, the sample must be random and is based on weight. There is a chart available. Product must be segregated and stored until it is approved. The Board may also order supplemental testing-at the facility or manufactures expense.
- 5. A marijuana cultivation facility shall use certified scales in compliance with AS 45.75.080 and 3 AAC 306.745.

## Marijuana Cultivation Facilities 3 AAC 306.400 - 3AAC 306.480 (continued)

- 6. A marijuana cultivation facility may not provide any one licensed retail marijuana store or marijuana product manufacturing facility with more than **one ounce of marijuana per month free of charge** for the purpose of negotiating a sale. See next slide. (must be returned, tracked and/or destroyed)
- 7. Must pay excise taxes monthly and submit business records as requested and show verification to purchaser (retail or product manufacturer):

  Sales and transfers of marijuana are subject to tax rates (01/2019).
  - Mature bud/flower are taxed at \$50 per ounce
- Trim is taxed at \$15 per ounce
- Bud/flower that is considered immature or abnormal.
   \$25 per ounce
- (This is bud/flower that didn't fully mature or develop, contains seeds, or failed testing.)
- Clones are taxed at a flat rate of \$1 per clone and not on the estimated weight, or transferred from a marijuana cultivation facility to a retail marijuana store or marijuana product manufacturing facility.
- 8. Marijuana cannot be seen or smelled from outside the facility by the public.
- 9. No one may consume marijuana or marijuana product within 20 ft of the exterior of any building or outdoor cultivation facility of the licensed premises.

A marijuana cultivation facility may provide a free sample of marijuana to a retail marijuana store if:



- it is packaged in a sample jar
- . it contains not more than three and one-half grams of marijuana
- it is protected by a plastic or metal mesh screen to allow customers to smell the product before purchase
- it must be tracked in the facilities tracking system and noted if it is destroyed or returned to the cultivation facility

# 2-Marijuana Product Manufacturing Facilities 3 AAC 306.500 - 3AAC 306.570

- 1. A marijuana manufacturing facility may not have an ownership interest in, or a direct or indirect financial interest in any licensed marijuana testing facility.
- 2. Must have sufficient knowledge of manufacturing equipment operation.
- 3. Manufacturing equipment must comply with health, safety, and fire codes and must be approved by an engineer
- 4. Marijuana product may only be sold to a retail facility.

- 5. Products cannot resemble a widely distributed food brand, must not require controlled temperatures (to keep it safe for human consumption) and the product cannot be an existing food product altered in any way
- 6. Products must be approved by the MCB prior to sale.
- 7. All product batches must be tested prior to sale.

3 AAC 306.500 - 3AAC 306.570 (continued)

8. Edible potency limits are set at **5mg active THC per serving (10 servings per package).** 

- 1. A retail marijuana store may not sell marijuana products to those under the age of 21
- 2. A licensed retail marijuana store may not sell, give, distribute, deliver, or offer to sell, give, distribute, or deliver, to any person under the age of 21;
- 3. A retail marijuana store may not sell more than **one ounce (5600 milligrams of THC)** of marijuana flower to a consumer per day.
- 4. Each entry to a retail marijuana store must be posted with a sign that says "No one under 21 years of age allowed." The sign must be not less than 12 inches long and 12 inches wide, with letters at least one half inch in height in high contrast to the background of the sign.

3AAC 306.300 - 3AAC 306.360 (continued)

- 5. A marijuana retail store must reconcile each transaction from the marijuana stores point of sale system and current inventory to it's marijuana inventory tracking system at the close of each business day.
- 6. The marijuana store shall account for any variance in quantity of marijuana product or marijuana sold, received, transferred or disposed of.
- 7. The marijuana store may not conduct business or allow a consumer to access the retail marijuana store's licensed premises between the hours of 5:00 a.m. and 8:00 a.m..
- 8. Sample jars may be used by retail stores so the consumer may smell the marijuana; they must be protected by a plastic, metal, or other protective mesh screen, and the jar must remain in the monitored custody of the retail marijuana store during consumer inspection.

### Retail marijuana stores:

- May not sell to intoxicated people under the influence of alcohol, inhalants, or any controlled substances.
- Alcohol may not be given away or sold on the premises
- All products must be appropriately labeled
- **Internet** sales are prohibited, the person must be physically present in the store to purchase products
- Stores may not sell any product past the expiration date
- Consumption on site is strictly prohibited, UNLESS the license includes a consumption endorsement
- Free product or samples are strictly prohibited

# Requirements for all Marijuana Establishments 3 AAC 306.700-306.755

- 1. Handler Permit is required, in immediate possession or valid copy on file at licensed premises and must be renewed every 3 years after taking a mandated certification course listed on the States website.
- 2. Alterations to the licensed premise must be approved by the board.
- 3. Areas where marijuana is grown, processed, tested, stored, or stocked is considered a restricted access area (5 visitors at a time, over 21 years of age and escorted by employee, agent or owner).
- 4. Security alarm systems and commercial locks are required, exterior lighting to facilitate surveillance, security alarm system on all exterior doors and windows

## Requirements for all Marijuana Establishments 3 AAC 306.700-306.755 (continued)

- 5. Forty days continuous video surveillance is required on the inside and outside of the establishment.
- 6. Licensed establishments are subject to board inspections at any time.
- 7. A Marijuana Inventory Tracking System is required for all establishments, from seed-to-sale.
- 8. Safety, code, and fire standards are required to be met, and adhered to.
- 9. Use protective hand coverings when handling marijuana Know and follow individual facility sanitary handling practices.

## Requirements for all Marijuana Establishments

3 AAC 306.700-306.755 (continued)

- 10. Waste disposal plans must conform to federal, state and local statutes, or ordinances, regulations and other law.
- 11. Labeling of marijuana and all marijuana product is required.
- 12. Standardized scales are required.
- 13. Only licensed establishments are authorized to transport marijuana in amounts exceeding personal limits.
- 14. Business records are required and must be available upon request of the board in a timely manner.

# Enforcement; Civil Penalties 3 AAC 306.800-306.850 Noncompliance (not following the laws and regulations) can result in the following:

- Suspension or revocation of an establishment license, and/or criminal charges against those involved.
- A marijuana establishment, and any licensee, employee or agent in charge shall cooperate with the director, an enforcement agent, an employee of the board, or a peace officer acting in an official capacity, and must:
- Permit entry and inspection of the licensed premise
- Provide access to business records at reasonable times

## **Enforcement**; Civil Penalties

3 AAC 306.800-306.850 (continued)

In addition to having a business license revoked for not being in compliance, the owner could be:

- fined up to \$50,000.00
- have marijuana or marijuana product seized
- receive a summary judgement (business license may be suspended)



#### Read: On-Site Consumption-Special Section


New to the State-Onsite Consumption requires an endorsement and must be approved by local government. Retail Stores may supply consumers with products in a designated area on the premise only. The following regulations apply to this endorsement which is attached to a specific license. Local laws apply-which may impact hours of operation etc...,

- This space must either be separated by walls and a door
- Have a separate ventilation system or be outside
- Employees must have a smoke-free area from which to monitor the consumption area
- The ventilation system must be able to remove visible smoke and adequate to remove odor at the property line.
- If it is an outdoor area, it must be compatible with uses in the surrounding area and have a sight obscuring wall or fence.
- · Onsite Consumption Limits-
- A person may purchase up to 1 gram of flower or 10 mg of edible products in a given day
- · for consumption onsite
- No concentrates can be consumed
- Other food and drinks (no alcohol) can be sold, and people can take unused products with them, packaged appropriately for exiting a licensed premise
- No outside products may be brought onto the premise
- employees may not consume product while on shift
- No tobacco products may be consumed at any time.
- No discounted pricing for product sold in the onsite consumption area beyond what is offered in the regular retail space that day may be observed
- No games or contests allowed



## How to determine valid identification:

- 1. Check the age.
- 2. Check the date to ensure license is not expired.
- 3. Look at the photo and person and make sure they are similar.
- 4. Check for a hologram, although not all identification will have this feature.

## Access IS restricted in a Marijuana Store:

# How to identify a person impaired by the consumption of marijuana

Commonly discussed chemicals in Marijuana THC (delta-9-tetrahydrocannabinol) acts on specific brain cell receptors that ordinarily react to natural THC-like chemicals in the brain. These natural chemicals play a role in normal brain development and function.

**CBD** (cannabidiol) may not affect the mind or behavior like THC, although some users have reported negative effects of high CBD/low THC strains and products. It may be useful in reducing pain and inflammation, controlling epileptic seizures, and possibly even treating mental illness and addictions. Marijuana over-activates parts of the brain that contain the highest number of these receptors. https://www.drugabuse.gov/publications/drugfacts/marijuana

The marijuana plant contains more than 500 other chemicals, including over 100 compounds that are chemically related to THC, called *cannabinoids*.

- Side effects vary from person to person, depending on quantity and strength of the marijuana.
- Marijuana also affects brain development.

  For example, a study showed that people who started smoking marijuana heavily in their teens and had an ongoing cannabis use disorder lost an average of eight IQ points between ages 13 and 38. The lost mental abilities did not fully return in those who quit marijuana as adults.
- Those who started smoking marijuana as adults did not show notable IQ declines. https://www.drugabuse.gov/publications/drugfacts/marijuana

# Inhaling or ingesting Marijuana-know how long it takes the body to absorb the THC.

- Inhaling: When a person smokes marijuana, THC quickly passes from the lungs into the bloodstream. The blood carries the chemical to the brain and other organs throughout the body.
- Eating or digesting: The body absorbs THC more slowly when the person eats or drinks marijuana. In that case, the user generally feels the effects after 30 minutes to 1 hour

### The effects of consumption:

- 1. Can cause Impaired coordination.
- 2. A person may experience difficulty in problem solving.
- 3. Marijuana consumption could cause short term memory loss.
- 4. People can experience anxiety and paranoia.
- 5. Some people experience hunger, referred to as the "munchies".
- 6. Marijuana can cause sleepiness.



#### Read: Amendments

#### Amendments (8/2019 updated):

The marijuana industry is new to Alaska so the laws are still being written and evolving, because of this the Alaska Marijuana Institute has added a module to keep you informed.

#### 1 Handler Permits

### Renewal Required-Handler Permit-check the date on your card from time to time. (Criminal Background Check Required)

A person may renew a card issued by taking a marijuana handler permit education course approved by the board and passing a written test demonstrating an understanding of the material every 3 years.

UPDATED: 8/11/2019

#### The board may suspend or revoke a Handler Permit:

- refuse to renew a permit
- · and/or impose a civil fine

if the holder acted in violation of the law

The board may choose to recind and marijuana certification course after reviewing the information, the cost to have a course reviewed or renew an is 500.00.

#### Required consumer notices for retail marijuana stores-keep signs current.

A retail marijuana store shall post, in a conspicuous location visible to customers, the following notices:

- 1. "Consumption of marijuana in public is prohibited by law."
- 2. "Transportation or carriage of marijuana or marijuana products on Alaska waterways, including cruise ships, or by air carrier is prohibited by federal law."

- 3. "Transportation or shipment of marijuana or marijuana products outside the State of Alaska is prohibited by federal law."
- 4. "Providing marijuana to persons under 21 years of age is prohibited by law."

#### Notification signs must be:

- 11 inches by 14 inches (or larger)
- lettering must be at least one-half inch in height and in colors that contrast with the background.

#### 3 Testing, Product and Product Labeling

### Labeling of Marijuana- just like things you purchase at the grocery store marijuana must be labeled

- The name and license number of the testing lab, results of the test
- name and license number of the manufacturing facility
- net weight of the product inside the packaging
- "organic" the word isn't allowed(FDA doesn't approve organic methods for cannabis)
- "grown using organic methods." may be used instead.
- The 5 warnings must be on each product:
- "Marijuana has intoxicating effects and may be habit forming and addictive;
- ""Marijuana impairs concentration, coordination, and judgment.
- Do not operate a vehicle or machinery under its influence;"
- "There are health risks associated with consumption of marijuana;"
- "For use only by adults twenty-one and older. Keep out of the reach of children"
- "Marijuana should not be used by women who are pregnant or breast feeding."

#### If a marijuana sample fails a test:

- all plants from that batch must be destroyed and entered into the tracking system.
- company may request to turn it into an extract (and test again)
- company may also request a retest, but it would be at their expense.

A testing facility must notify the Board of Directors within 24 hours in the event of equipment failure that occurs during testing and that may impact completion

**IF you own, operate or are an employee of a marijuana testing facility** the State requires that you establish procedures to ensure that reported results are accurate, precise, and scientifically valid. To ensure reported results are valid, a marijuana testing facility shall report results in compliance with guidelines prescribed by the board and include in a final report in accordance with 306.670 (b)

#### Samples

#### From cultivation facility to retail store:

A marijuana cultivation facility may provide a free sample of marijuana to a retail marijuana store if:

- it is packaged in a sample jar
- it contains not more than three and one-half grams of marijuana
- it is protected by a plastic or metal mesh screen to allow customers to smell the product before purchase
- it must be tracked in the facilities tracking system and noted if it is destroyed or returned to the cultivation facility

#### From retail store for consumers benefit:

If a retail marijuana store displays marijuana to a consumer for the purpose of smelling the marijuana before purchase, the retail marijuana store shall:

 package the marijuana in a sample jar that is protected by a plastic, metal, or other

protective mesh screen

• jar must remain in the monitored custody of the retail marijuana store during consumer inspection.

#### Employees can test for quality control-important to retail employees-please read:

A marijuana product manufacturing facility may provide a sample of marijuana concentrate or other marijuana product to an employee of the facility, who is in possession of a valid marijuana handler card for the purpose of quality control.

- samples may not exceed 1 ounce in a 30 day period
- · quality control form must be completed
- they must be entered into the tracking system
- · they may not be sold

#### Both marijuana and marijuana products sold may not contain more than

- 5,600 milligrams of THC
- · limits include marijuana or marijuana product sold for onsite consumption

#### 4 Applications and Licensing:

Denial Of Application for License

The Board may review an application, including the applicant's proposed operating plan

and all relevant information, and may deny the application based on the following:

- submitted incomplete
- · violations based on location of business or licensees
- · a local ordinance
- inadequate operating plan

- not in the best interest of the public
- renewal applications may be denied because of a previous violation or condition of operation in the previous year, or delinquent taxes

The board must notify the applicant within 15 days of denial.

 the applicant may request an informal hearing with the director or with the board

and it may be executed telephonically

- a formal hearing by filing a notice of defense may ensue and must be done within 15 days of the denial or after the informal conference
- the board may request that the formal hearing be conducted by the Office of Administrative Hearings
- an applicant may also appeal to the board any action of the director or an employee or agent of the board regarding the application
- they may also present their case to the superior court

### The following information about protest of local government is important to a business owner who must obtain approval from a local government:

The "local government" has ONLY 60 days after the director (the director of the Alaska Marijuana Control Board) sends notice of application for a marijuana establishment to protest the application.

- the local government may include what conditions must be met and the director and board will require them prior to approval
- the local government may **decline the application** and it will be denied unless the decision appears to be arbitrary or capricious.

#### Application establishment fees including onsite consumption and requirements:

- 1. Onsite Consumption requires an additional endorsement, the licensee must apply and the application fee is \$1,000.00 the annual non-refundable fee is \$600.00 (this applies to all establishments).
- 2.The holder of an onsite consumption endorsement must apply for renewal annually at

the time of renewal of the underlying retail marijuana store license.

3.A designated area for onsite consumption must be separated from the remainder of the

premises, either by a secure door and include a separate ventilation system, or by being

outdoors in compliance. (additional regulations will apply 06/2019)

(A change fee does not apply to an application for transfer of a license or a transfer of controlling interest to another person.)

<u>The marijuana establishment</u> must operate under the plan approved by the board, any changes of this plan must be applied for and approved by the board.

#### Fingerprints-when you file for a license, what to expect:

When filing an application for a new marijuana establishment license, transfer of a license

or ownership change, the applicant, including each individual listed must submit the person's fingerprints and the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information.

An individual who has submitted fingerprints and fees under this section is not required to submit a new set of fingerprints and fees if the second or subsequent application is

submitted *not later than 12 calendar months* after the date criminal justice information

is received in response to the initial submission of fingerprints and fees.

The director shall submit the fingerprints to the Department of Public Safety to obtain a report of criminal justice information under AS 12.62. The board will use the information obtained under this section to determine if an applicant is qualified for a marijuana establishment license.






