## MEMORANDUM

TO:Marijuana Control BoardDATE:September 11, 2019

RE: Raspberry Roots, #10098, Standard Cultivation Facility

Raspberry Roots is a standard cultivation facility located in the Municipality of Anchorage, owned by Raspberry Roots, LLC. At the time of the requests discussed in this memo, Raspberry Roots, LLC, was owned 100% by Kim Kole. A transfer of controlling interest was effectuated in March of 2019, and the entity is currently owned 55% by Jerry Workman and 45% by Kim Kole.

In November of 2018, Ms. Kole sent a request to transfer multiple failed harvests to her manufacturing facility for extraction in accordance with 3 AAC 306.660(b). Several days later a request relating to additional harvest batches was submitted. Twenty-eight MJ-22b forms for the various harvests were submitted on December 10, 2018.

Of those 28 harvests, eight had already been transferred from Raspberry Roots cultivation facility to Raspberry Roots product manufacturing facility (#10856) without approval from the director or the board in violation of 3 AAC 306.660(b).

For 27 of the 28 requests, each entire harvest was packaged as leaf/trim with the exception of 4 grams from each harvest that was packaged as bud/flower to send for testing. As all the harvests were marked Finished in Metrc, all marijuana from the harvest was packaged, so the implication is that each harvest produced only 4 grams of bud/flower for a total of 108 grams of bud/flower (0.3%) out of the 34,653 grams that were harvested from the 755 plants that make up those 27 harvests. This is not a believable conclusion.

When asked about the situation, licensee's counsel responded in the attached email, admitting to entering incorrect information into Metrc.

For the 28<sup>th</sup> request, the package tag provided with the MJ-22b request was incorrect, and the package tag provided with a "corrected" request does not show in Metrc.

This situation continues to be under investigation and I am working on an accusation to bring to the board. The issues related in this memo will be included in the accusation. I request that the board take no action on this matter at this time.

I am emailing you in order to gain permission to extract, via Raspberry Roots 5a-10856 manufacturing license, our 4a-10098 cultivation failed product. Recently, our cultivation has had some struggles and some harvest batches failed microbial testing, so I am asking permission to run them through our manufacturing so we can recover some of the financial loss associated with such a result.

I want to first apologize and own up to the fact that we almost made a mistake regarding our manufacturing. We have had numerous cultivators call us to take their failed product to extract (they are trying to recoup losses so we understand but haven't purchased any) and also have purchased extracted material (concentrates, vapes, etc.) for our retail that were produced with Failed Product. Therefore, I made an assumption that transferring and extracting failed material was an everyday norm. As I was refreshing myself on the Regulations regarding manufacturing testing guidelines I came across the line which states one must get permission from the Director to extract failed material so that brings me to this email.

I have already transferred failed product to our Manufacturing License, even paid taxes on some of the product, and have run some of that product through our extraction process. We, as an internal decision based on the integrity of our brand and character and prior to refreshing ourselves on the regulations, actually sent a sample to CannTest (Metrc#

1A40203000070E500000017) of our first run to make sure we were in fact able to clean out any fungus or microbial. The average closed-loop hydrocarbon extraction unit (same as our process) uses 20-25 filtered paper, but we have gone to a more expensive 5 micron filter polyester bag to ensure that it would produce clean product. The Passed microbial result extracted from failed material is attached to this email. We have not sold / transferred any finished product out of our manufacturing facility yet - nor have we submitted any of the product for official potency/solvent/microbial testing yet.

With your permission, we would like to finish the Extraction process on the failed batches listed below:

Also, we submitted samples Tuesday for the latest harvest, and we do not know what to expect from that room. Given the situation, we do expect some to come back with issues. However, that will be the last Harvest for a long while as we have decided to "clean house". We do believe we have found the source of the issue, so we finished the crops that were mid season and have since not loaded anymore plants.

Corrective actions taken:

- > Destroyed the plants that could have been the root of the issue.
- > Evacuated all rooms of plants and cleansed thoroughly with bleach.
- > Repainted a room with mold-resistant paint.

> Installed higher temperature rated Fire Sprinkler gauges so that we could use the lights to reach 130 degrees temperature within the rooms - all the equipment stays in the rooms as well - and temperatures that high will kill any living organism, which the fungus needs to live/grow. We will heat the rooms multiple times prior to adding plants.

To express the magnitude of this situation and further display the financial burden we are undergoing to rectify the current situation, the rooms cost us about \$2,000 a day being empty (overhead costs) and one of them has been empty for over a month now.

An all natural remedy of essential oils and specific heavy light treatments is the basis of our improvement plan. Given that this is agriculture, the problem will not go away 100% overnight, but by cleaning out the rooms completely and starting from scratch we should gain back control and slowly progress into 100% elimination! I am sorry to have to bother you with these time draining requests, but this is my livelihood. I have sank everything into this dream of mine and I am barely hanging on financially so this is so important to me.

Good afternoon Erika, thank you for your email dated Aug. 15<sup>th</sup>.

The Leaf/Trim denomination was just a place holder as there was no IMMATURE BUD option available at that time. All of the marijuana at issue was immature bud and very leafy, creating a majority of trim. Raspberry Roots entered in metrc all of the product as trim, but based on visual (because there was no business sense in trimming larfy immature and leafy bud and therefore no way to note the differing weights in metrc), which resulted in all the product being entered as trim in metrc. However, Raspberry Roots did assigned a percentage to the harvests as bud/flower for tax reporting reasons, and paid the bud/flower tax for 25-30% of the harvests. As you will see, for example, on page 6 of the October filing, Raspberry Roots paid between 25%-30% of the product as if it were bud/flower, based on visual estimation of the harvest and identifying how much could be classified as bud/flower and paid that amount to revenue in addition to trim tax.

Raspberry Roots had full intentions on paying an estimated tax split between Leaf/Trim and Bud/Flower as they have displayed this integrity in their previous filings.

Like mentioned before, as new license holders going through learning curves, they had moved failed product to their Manufacturing License prior to getting permission and they did in fact pay an estimated split between Leaf/Trim & Bud/Flower. There is no feasible way to actually decipher the exact breakdown percentage (as this product cannot be sold as Bud/Flower and there is no pointing spending more costs Trimming the product), but their estimate shows to be very acceptable as their estimates equated to slightly above the new rate of \$25/OZ of Immature Bud.

Hi Erika – the text of my email below got cut off – here is the remainder of my email below, which are Kim's explanations on two of the questions you answered (that I didn't include in my last email below that I SHOULD'VE included:

For '207 MGT 100418' = From Kim Kole;

For the request for 207 MGT 100418, it has come to our attention that the package was not completed. During training process of a new Employee, Dana Gillian, the tag number 1A4020300003BC5000001283 was mistakenly used - and then discontinued. We checked the history of the 207 MGT 100418 Batch and there was never a package finalized so we have given the product a new METRC tag to satisfy the organizational purpose of transferring the product to another license. Pictures of the product with the 1A4020300003BC5000001283 tag is attached. As well as the corresponding new tag and new request from.

For 'Q CHC 092118' = From Kim Kole;

We heard that other cultivators had gotten product retested when they didn't think the results were accurate. We thought it was as simple as being able to pull 4 grams from the package and resending it to the lab. Since Metrc also allowed us to do so, it didn't occur to us that this would be a problem. I have attached the manifest with the 4 g sample to Canntest included.

As far as "Bud/Flower" classification, that is just a habit and the way I thought all samples are supposed to be submitted. It has no effect on our opinion of the situation and we will no longer do that moving forward.

Additionally, given the length of time it has been taking to get responses from you on this matter – if we don't hear back from you by end of day tomorrow, please consider this our formal request to appeal your determination to the marijuana control board and please confirm this will be calendared for the September MCB hearing.
