October 17, 2018

We were having air pressure flow issues with the automated controls for the air system and brought in LONG SYSTEMS to fix this issue, anticipating it would also address odor escapement.

December 28, 2018

NOV issued. We added 6 new additional carbon air filters throughout the grow to help scrub odor before it gets exhausted outside.

February 14, 2019

NOV Issued. Called in the air system engineer, Chris Linford who designed the air system to ensure proper functioning of overhead forced air units. At the same time we had General Mechanical also visit on site to make certain the air filtration system was operating correctly. We then sealed exterior wall to prevent air leakage and repaired the air pressure problems in each flower room where the odor is the strongest, by creating negative pressure and ensuring the negative pressure stays constant.

June 2019

This month we are also implementing an active carbon replacement every two months as a back up to our odor containment protocol.


