This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 02/25/2019 AMCO Enforcement received a complaint of a strong odor of marijuana in the vicinity of the 1900 block of Donald Avenue and the Metro Field Airport in Fairbanks, AK.

During my investigation I detected a strong odor of marijuana in the 1900 block of Donald Avenue and from the access road on Metro Field Airport. Upon further investigation I determined the odor of marijuana was emanating from the GOOD, LLC marijuana cultivation facility at 1949 Frank Avenue, Fairbanks, AK.

Your attention is directed to:

3 AAC 306.430: Restricted Access Area-

(c) A marijuana cultivation facility shall ensure that any marijuana at the marijuana cultivation facility

(2) does not emit an odor that is detectable by the public from outside the cultivation facility except as specifically allowed by a local government approval.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.

If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

**Note: This is not an accusation or a criminal complaint.**

On March 1, 2019 Good LLC self-reported an error made the same day during the creation and use of a manifest for products destined for their own retail store, license #12325. The METRC manifest reflected package ending in #2033 was sent over in error to the store when it should have been package ending in #2036. Package #2033 was accepted into the retail store system. A "virtual manifest" approval was required to correct the error.

This is a violation of 3 AAC 306.435 (b) Marijuana inventory tracking system and 3 AAC 306.750 (b) & (c) Transportation.


**3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.**
