This is in response to the NOV #AM190664 we received on April 29, 2019. We have also attached the email in response to the violation. We spoke directly with James Holscher about this issue and he informed us the NOV would be rescinded, as the topic of the ambiguity of a 5600 mg limit and the variety of ways that would actually be met in reality (a flower testing more than 20% would not actually be able to be sold at an ounce and stay within regulation etc.) At the MCB meeting in July the regulation was even addressed where Mr. Holscher informed the board he was in contact with us and it was an ambiguous regulation that did not have a clear answer. We reiterate that this was cleared up with Mr. Holscher before the MCB meeting in July AND at the meeting. We look forward to clarity around the issue of a 5600 mg max sale in the future.




