E&M Holdings, LLC, dba The Stoney Moose, received three NOVs the past license year. Two of these NOVs were due to an error in METRC created during a transport manifest. Although the errors were minor (wrong date and time for one NOV, and the other NOV was applied after we noticed an error in a transport manifest and tried to fix it), they were in violation of the parameters set by AMCO. New review methods for manifests double-checking by our enforcement officer were set in place after this happened, and no NOVs based on these similar transportation problems have occurred since.

1st NOV - cannot find 2nd NOV - Case: AM190273

The third NOV occurred due to an error in a publication of a magazine; the editor of the magazine inadvertently cut out the AMCO regulated warning and our store ID# in an advertisement we placed. We noticed the error when the magazines were delivered, and immediately notified AMCO Enforcement of the violation. Since that NOV we have implemented changes in our advertising that requires a sign off by our enforcement officer before any and all advertising can go out of the store.
