This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

**Note:** This is not an accusation or a criminal complaint.

It has come to the attention of AMCO that some marijuana retail establishments have been consuming marijuana product for "In-house quality control." This conduct is only permitted for cultivation and product manufacturing facility license types per Alaska Regulation.

Hollyweed 907 has made 34 package adjustments for in-house quality control for the time period of 12/1/18-1/31/19. Richard Morrisette stated on 2/5/19 that they sampled out 10 grams of concentrate to employees on 1/28/19. In the same time period I see in the notes that there were 4 other times were employees sampled product.

This is in violation of 3 AAC 306.310(b)(3)(A)

Please note that in: 3 AAC 306.460. Samples (d), 3 AAC 306.557 Quality control sampling, those actions are only allowed for cultivation and product manufacturing license types.

**3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.**

To Whom it may concern,

My name is Rick Morrisette and I'm the Store Leader of Hollyweed 907 here in Anchorage, AK. This facility is a vertically integrated company that handles Cannabis from seed to sale. I spent a part of my afternoon today talking with Jeff Rukes, going over some issues he came across in our Metrc handling. He informed me that using the "In-House Quality Control" option is something that can only be used by the cultivation and manufacturing licenses. I have a trusted staff that handles the day to day operations of the retail and they have volunteered to help with some of the Metrc duties. Now without my knowing it appears that some of my staff may have been making adjustments in Metrc improperly. I too am guilty of this, due to simply not knowing a recent change.

Now this is still an error on my part and as part of running our business it falls on us to stay up to date with changes and updates to regulations. I'm here today to speak to those mistakes and to share ways to prevent these errors from happening in the future.

First off making adjustments in Metrc; only a small number of my staff has any ability to change and adjust products. Today I'm meeting with each individual and having an in-depth refresher conversation about proper procedures when it comes to adjustments. Second off, I'm making a commitment to follow up with each adjustment every week to better understand why these adjustments were made so I can better speak to them if anything like this should ever occur again. Finally, I plan on bringing up adjustments in my weekly leadership meetings with the owners and senior staff so that way everyone has oversight.

I understand that these actions invoke a violation towards our license but I hope the board understands that this was an oversight mistake on my part and I will do everything within my powers to prevent anything like this from happening again.

Thank you for your time in reading this letter and I hope this violation doesn't reflect too poorly on our record.
