If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On Thursday, April 18th, 2019 at approximately 4:00 pm. The Alcohol & Marijuana Control Enforcement unit did receive a odor complaint from an Alaska State Trooper who was in the Palmer AK area. The Trooper reported the odor of marijuana was easily detected and was reported as coming from Will's World, a limited marijuana cultivation facility in Palmer AK.

Please regard this Notice of Violation as AMCO Enforcements directive that Will's World, LLC will ensure that any marijuana or marijuana product at the facility does not emit an odor that is detectable by the public outside of the cultivation facility.

This is a violation of:

- 3 AAC 306.430 Restricted access area. (c)(2)
- (c) A marijuana cultivation facility shall ensure that any marijuana at the marijuana cultivation facility
- (2) does not emit an odor that is detectable by the public from outside the cultivation facility except as allowed by a local government conditional use permit process.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.
