You have 30 days to resolve this matter with the Department of Revenue. If the delinquency is not resolved, an accusation will be brought to the Marijuana Control Board.

Marijuana tax to be paid; 3 AAC 306.810. Suspension or revocation of license; AS 43.61.030(b). Marijuana cultivation facility fails to pay tax; AS 43.05.230(e) DOR can publish list of taxpayer(s) who failed to pay their taxes.; 15 AAC 61.020. License revocation and suspension.

I Jason M Bott, am writing this letter in explanation of two Notices of Violation as received from AMCO for Lic # 12872.

Both NOV's were for being late in paying the excise taxes due.


By way of explanation, for the one dated 6/3/2019, I had in fact paid the taxes on 05/20/2019, prior to receiving the NOV, in fact having over paid according to the voucher amount shown on the dept of revenue website as of the day I made the payment. In speaking to Ms. Etheridge at the excise tax division, the tax amount due was adjusted after the payment had been made on 5/20, and this resulted in another amount also being due, of which I was not aware.

While it is NOT an excuse, we have had 3 failed harvest batches due to aspergillus, and this, along with the cost of the remediation of the problem put a large dent in revenue coming in to cover expenses and taxes. We even waited nearly 45 days for the permission to be granted on the MJ-22b to sell the failed product, putting us even further behind. We are catching up on the situation, and will be fully current in the very near future, and will do everything that we can to not be in this position again.

The previous NOV was much the identical situation, with failed harvest batches, and the payment of expenses while not being able to generate the revenue we had expected. However, we did not undertake the extensive remediation measures that we did this time, as we couldn't afford to perform them at that time.

We are doing our best to comply, and will undertake any and all measures available to us to ensure that this situation doesnt arise in the future.




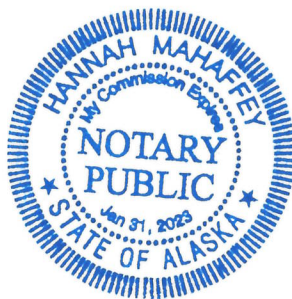
