Rosin bags are loaded with cannabis plant material. Rosin bags are then exposed to applied heat and pressure. Through this process sappy resin is extracted from the plant material. The sappy resin is then cooled to yield a final product known as rosin. Pressed plant material will be handled and recorded according to the operating plan cannabis waste procedures. Finished rosin will be portioned into packages for distribution.



Shatter has a solid glass-like texture and consistency and will be produced in color gradates of amber varying from dark to light. Shatter shape is flat and organically amorphous.

Ingredients:

Cannabis flower and/or trim.

Standard Production Procedure and Detailed Manufacturing Process:

Cannabis material is submerged in -40 C (or colder) ethanol for a period of time. The ethanol solution is then subjected to a series of phased filters and dramatic temperature changes to isolate and separate the cannabis fats from the ethanol. The liquid, isolated cannabis fats are then poured onto a sheet tray and placed in a vacuum oven for a period of time. The fats are then removed from the oven and allowed to cool. Processed plant material will be handled and recorded according to the operating plan cannabis waste procedures. Finished shatter will be portioned into packages for distribution.
