# **Product Description:**Details must include the color, shape, and texture.

Dab Tabs are small, octagonal-shaped, inert, ceramic tablets (sometimes referred to as a "Dablet") filled with marijuana concentrate for vaping. Each Dablet is engineered to function as a matrix, holding a specific volume of marijuana concentrate (approximately .05ml), containing approximately 50mg of marijuana concentrate per "Dablet". The dablets are dry to the touch, not sticky, and do not break apart, leak, or otherwise "sweat out" the marijuana concentrate contained within them. Dab Tabs react to heat and are designed to be vaped. As the dablet heats, the concentrate will boil out for the user to vape/inhale. After all of the concentrate is consumed, what will remain is the empty charred ceramic husk of the dablet, which can be then be disposed of. The color will vary from light yellow to amber, depending on the coloration of the concentrate and how full the dablet is.

#### **Ingredients:**

Dab Tabs themselves are made of a natural mineral-based ceramic material, sourced in the United States. Dab Tabs are certified to NSF/ASTM 61 standards as a media pure enough to be used in drinking water filtration. Dab Tabs are engineered to hold a specific volume of marijuana concentrate. The Cold Creek Dab Tabs will contain marijuana concentrate produced by Cold Creek Extracts (such as Full Extract Ethanol Hash Oil, Shatter, Sugar Wax, or distillate) or another manufacturer. In all instances, the specific type of concentrate that was used for the particular batch of this product will be reflected in METRC and listed on the product label.

## Standard Production Procedure and Detailed Manufacturing Process:

Dab Tabs are filled by infusing marijuana concentrate into each dablet. This process involves warming the marijuana concentrate under controlled vacuum pressure, which will liquify the concentrate and allow a specific amount of concentrate to be absorbed into each individual dab tab (approximately .05ml of liquefied concentrate will be infused into each dablet). Then the filled dablet will rest while the concentrate cools and solidifies.

Dab Tabs will be sold in packs of 5 (containing 5, 50-mg dablets with approximately 250mg of total THC), 10 (containing 10, 50-mg dablets with approximately 500mg of total THC), or 20 (containing 20, 50-mg dablets with approximately 1g of total THC).

Marijuana tincture will be packaged in a small clear or opaque 30ml child-resistant bottle. The bottle will have a 1ml dropper attached to the child-resistant lid. One dropper-full will contain 1ml of tincture, which will contain approximately 1.6mg of THC. The serving size is for this product is three droppers-full, which will contain approximately 5mg of THC. Each bottle will contain no more than 50mg THC. Each bottle will contain up to 10 servings. Child-resistant bottles may have a label applied directly to the bottle, or bottles may also be sealed within a child-resistant plastic or mylar bag, or cardboard box. Packaging information will also reference different "blends" or flavor profiles depending on the type of concentrate used and selected combination of essential oils and herbs.
