RSO oil is a Marjijana Concentrate. MCT (medium chain triglycerides) oil may be used as a diluent if necessary to obtain the right viscousity.

### **Standard Production Procedure and Detailed Manufacturing Process:**

To make RSP Oil, Marijuana is soaked in ethanol. Marijuana is separated from the ethanol and the extracted ethanol is evaporated using a solvent recovery system. The resulting oil is decarboxylated. The oil may be mixed with MCT (medium chain triglycerides) oil and homogenized to achieve the desired final viscosity. A random sample of the resulting oil will be submitted to a licensed testing facility for analysis. 1/2g and 1g amounts of the final oil will be inserted into a syringe with a dosing gun and weighed for accuracy. The filled syringe will be placed in a plastic blister package with a paper cardstock insert with product details.







Candy is cooked and infused with 5 mg of cannabis distillate oil per piece. Candy is poured in molds, set aside to cool and fluffed with sugar as a coating. Candy is packaged as single air tight flow wrapped pieces in a box of four (4) and labeled.


