What is this form?

This proposed new marijuana product form is required for a marijuana product manufacturing facility licensee who is seeking Marijuana Control Board (MCB) approval of a new marijuana product or marijuana concentrate for production at its licensed premises, as required under 3 AAC 306.100 and 3 AAC 306.525. **The required \$250 proposed new marijuana product fee may be made by check, cashier's check, or money order.**

This form must be completed and submitted to AMCO's main office prior to production of any new marijuana product or marijuana concentrate. **The proposed new marijuana product may not be produced unless and until the MCB has approved of the product.**

Please note that licensees seeking approval of more than one proposed new marijuana product or marijuana concentrate must submit a separate completed copy of this form and pay a separate fee for each proposed new marijuana product or marijuana concentrate.

Beverage flavorings, infused with THC distillates, in small bottles (2 oz./60 mL), intended to be added to a beverage of one's choice. Each bottle contains two (2) x 5 mg. doses (10 mg. per bottle). Bottles are marked at the halfway point on the label to indicate the 5 mg. dose. Splashes are available in five flavors: Spearmint Splash: Pale, Yellow/Green hued, with slight haze. Sweet & minty flavor. Hibiscus Splash: Liquid, Crimson hued, with slight haze, sweet and sour taste. Poncho's Punch Splash: Yellow/Amber hued, with slight haze. Sweet & spicy flavor characteristic of ginger and cinnamon. Spruce Tip Splash: Liquid, Yellow/Green hued, with slight haze, sweet & sour, piney taste. Fireweed Splash: Liquid, amber/magenta hued, with slight haze, sweet and sour taste.
Ingredients:	Spearmint Splash: Purified Spring Water, Spearmint, Honey, Citric Acid, Yeast Extract, Olive Oil, Quillaja Saponaria extract, Spearmint & Lemon Verbena essential oils, THC distillate, Cannabis terpenes, edible mushroom extract, Ascorbic Acid (Vitamin C). Hibiscus Splash: Purified Spring Water, Hibiscus Tea, Honey, Yeast extract, Olive Oil, Quillaja Saponaria extract, THC distillate, Cannabis terpenes, Lavender essential oil, and edible mushroom extract, baking soda. Poncho's Punch Splash: Purified Spring Water, Ginger, Cinnamon, Honey, Citric Acid, Yeast extract, Olive oil, Quillaja Saponaria extract, THC distillate, Cannabis terpenes, edible mushroom extract, Ascorbic Acid (Vitamin C). Spruce Tip Splash: Purified Spring Water, Spruce Tips, Honey, Yeast Extract, Olive Oil, Quillaja Saponaria extract, THC distillate, Cannabis terpenes, edible mushroom extract. Fireweed Splash: Purified Spring Water, Fireweed Tea, Honey, Yeast Extract, Olive Oil, Quillaja Saponaria extract, THC distillate, Cannabis Terpenes, edible mushroom extract.
Standard Production Procedure and Detailed Manufacturing Process:	Emulsify THC distillate & Cannabis terpenes. Homogenize with natural flavorings & Honey. Pasteurize, and bottle using specialized vacuum filler/ capper.

Packaging Description:

Details must include the color(s), size, packaging materials used, total amount of THC, individual serving sizes (if multiple), and other specifics showing compliance with 3 AAC 306.565. Please include photos, drawings, or graphic representations.



• Splash will be sealed with 20-400 Black P/P Push and Turn Child Resistant Closures. Caps feature F-217 Foam Liner to make a positive seal. Colored stickers will be applied to the caps, (purple, orange, and green) to indicate the dominant strain: Indica, Sativa, or Hybrid.

• Splash will be bottled in 2 oz./60mL. amber colored glass Boston round bottles.

• Each 2 oz./60mL. bottle contains 10 mg. total THC, with two (2) servings of 1 oz./ 30 mL containing 5mg THC each serving, clearly delineated on the label with a marker bar calibrated to accurately measure each serving.
