This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 08/19/2019 Susan Burrell, designated licensee of Marijuana Retail Store #10163, The 420 notified AMCO Enforcement she had inadvertently accepted a package in METRC which was not due to be delivered until the following day. AMCO was later informed it was a manifest for packages; **2934, 2935, 2936, 2937, and 2938 which was accepted and not the packages themselves.

This is a violation of 3 AAC 306.330(b) Marijuana inventory tracking system.

This violation was self reported.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.

IT IS RECOMMENDED THAT YOU RESPOND IN WRITING TO DOCUMENT YOUR RESPONSE FOR THE MARIJUANA CONTROL BOARD.

What you are seeing is that they changed the date on the manifest as soon as the flight was canceled. The violation should say - "which was not due to be delivered until later in the day. The date was changed due to airline flight cancelation."

This kind of accident could be averted if the manifest area, where it is accepted, did not auto fill the receivers amount, which can be changed upon arrival of the actual product, BUT-if it were left blank than the transfer could not be accept until the weights where put in by the retail or whomever.
