This is a notice to you as licensee that an alleged violation has occurred. If the Marijuana Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 6-20-19, I spoke with your on-duty manager about adding another camera to your rear exit so that 180 degrees could be observed. We agreed that two weeks was a reasonable amount of time to install the camera and if there were any issues about doing it, to contact AMCO. On 7-10-19, you were issued an advisory notice because a camera had not been added. As of 7-22-19, you still have not contacted AMCO if you have an issue with the requirement or installed a new camera.

Your attention is directed to 3AAC 306.720: Video surveillance, which in part reads (b) At a marijuana establishment, a required video camera must be placed in a way that produces a clear view adequate to identify any individual inside the licensed premises, or with in 20 feet of each entrance to the licensed premises. Both the interior and exterior of each entrance to the facility must be recorded by a video.

3 AAC 306.805 provides that upon receipt of a Notice of Violation, a licensee may request to appear before the board and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice of Violation. A licensee may respond, either orally or in writing to the Notice. 3 AAC 306.810 (2)(A)(B)(C) failed, within a reasonable time after receiving a notice of violation, to correct any defect that is the subject of the notice of violation of AS 17.8 or this chapter.

Apparently, we received an NOV (attached) on 7/23/19 that I was not even aware of until just recently on 8/26/20 when I was contacted in a Incomplete Renewal Notice (attached) by the licensing dept for my renewal of license #10170 telling that I had an error on my MJ-20 informing me that I did not disclose this NOV. I had no previous knowledge of this NOV at all, I had to ask the licensing staff to send me a copy of the NOV as it is something I had never seen. As a result, I never had the opportunity to respond to this NOV as I never received a NOV from enforcement. I checked all possible email inbox's, I never received anything in the mail, and I never received a phone call informing me that we had received a NOV. If I had I definitely would have responded and requested to be heard by the board regarding this NOV.

This NOV was issued due to what appears to be failure to respond to a request by an enforcement officer to have another camera installed at our back door, please keep in mind this request came after we had already been operating with the same camera setup and premises layout for over a year that enforcement inspected and approved prior to us receiving our license. Nothing had changed with our license aside from the request by enforcement to install another camera to better capture the area outside our back door to the facility.

On 6/20/19 I was contacted by Katie Thomas the store manager that received the request by enforcement to install another camera. She did mention that the enforcement officer requested us to install another camera, but she did not tell me the officer put a 2-week timeline on it. Please note that I didn't receive any direct communication about this issue from enforcement until I received a phone call on 7/9/19 from an enforcement officer asking me if we had installed a camera yet. I informed the officer that we had not yet been able to install another camera but we were working on it, as our DVR was maxed out on channels, meaning our recording equipment didn't have the room for another camera, but that we ordered another camera that would record on a separate DVR and we would get the camera installed as soon as possible.

The next day on 7/10/19 we received an Advisory Notice (attached) informing us that we had until 7/18/19 to get the camera installed. I did not contact the AMCO office as I did not foresee any issues with us getting the camera operating before 7/18/19 as it was in route. The camera was installed the day we received it in the mail. I do not recall what the exact date of installation was although I believe it was before 7/18/19.

I am requesting that this NOV be expunged for a few reasons that are given above but the biggest reason being that I never received an NOV from enforcement on this issue.
