On March 20, 2020 We received a notice of violation for delinquency of marijuana excise tax liability from Joe Hoelscher. The notice of violation was only sent as an email and that email was from Jason Davies. Both the email that it was attached to and the NOV demanded to resolve the issue with the Department of Revenue within 30 days. I have been attempting to work with the State of Alaska Department of Revenue for over 22 months and have regularly been in contact with them, the idea that they contacted the AMCO board and then received help from enforcement is disturbing. If enforcement has no authority to assist licensees when dealing with state agencies, state agencies should not be contacting enforcement, and then receiving help to harass licensees. Being a licensee does not make me a criminal, state officials using their positions to subjugate is criminal.

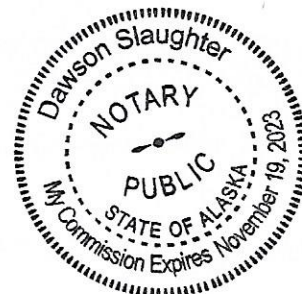
