## Explanation of Notices of Violation received

To whom it may concern,

In explanation as to the NOV received during this previous licensing period, it was the result of a mistake on my part, in that while I did in fact pay the excise taxes, I had neglected to include the additional interest and penalties that had accrued in the days between the time I printed the voucher and then made the payment, as I failed to consider the fact that they accrue daily, and would subsequently change the amount owed DAILY.

I am current in my taxes at present and I am in compliance with the Dept of Revenue in all respects. And while not an excuse, after having a tough time of it for a couple of months, with unforeseeable expenses due to equipment issues and a failed harvest previously, the structure of monthly payment, the amount of taxes due per month, and the unforeseen hits to working capital left me short in terms of having to choose between paying the excise taxes, or keeping afloat by paying the operating expenses until I could make up for the shortfall in terms of liquid cash. And this is a relentlessly compounding issue, as the next months taxes are always a factor as well.

Again, its not an excuse, but simply the choice that I had to make at the time, and frankly, I NEVER intend to be in that position again. But in any other business, that is where a line of credit, interim loan, etc., would be the applicable answer in such a situation, but those are options not available to us in this industry at present.
