

We urge you to consider all the objections that we, and others in the Farm Loop area have to this type of activity in our rural area.

We bought our property in 1976, moved into our home in 1980, and have lived here ever since. We raised our family of five children. We have developed the land and have continuously farmed it since then.

This area of Farm Loop is a farming community, with generations of residents beginning in the early colony days. Some of the property around Farm Loop has been developed into subdivisions over the years, and those homeowners are raising young children. Farm Loop Community Church is a flourishing church and school. We have an active Community Council (Great Farm Loop Community Council). We care about our area and keeping the rural, neighborly, family-oriented atmosphere.

The proposed site for the Retail Store for High Society is at 6514 N. Farm Loop Road, Building #2. It is directly on the corner of the Glenn Highway and Farm Loop Road. There is a family with children across from the site to the south, and also several residential lots with children adjacent to the property west of the site. About ½ mile west of them is Farm Loop Community Church and NOLS (National Outdoor Leadership School). Down the Glenn Highway a few hundred feet is the Stephan Fire Station with active traffic from fire trucks, ambulances, and firemen coming and going from the Fire Station at all times of the day and night. They would have difficulty getting to and from the Fire Station, causing delays in firemen and fire trucks arriving at a fire. This site is also used for Life Flights if a helicopter needs to transport accident victims quickly.

Our driveway is directly opposite of the entrance of Farm Loop Road, to the east. There is already high traffic at this intersection of the Glenn Highway and Farm Loop and our road E Riverwood Circle.

We object for the following reasons:

- 1. This is a farming, family-oriented area and having a marijuana retail store does not propagate those values.
- 2. Traffic would increase in getting on and off the Glenn Highway for everyone, not just us and our neighbors for Riverwood Circle.
- 3. There is no turn-around area for potential customers leaving the premises of the proposed site, other than backing out onto Farm Loop, creating a traffic hazard, particularly in the winter, dark, slippery driving conditions coming soon.
- 4. The potential customers are not the type of people who put family values first.

- 5. The potential customers could/would interject violence, robbery, unsavory conduct. Safety in our homes is a concern for all in this area.
- 6. We already have a gate across our driveway, due to people who "pause" in our driveway off the Glenn Highway, leave trash, use our premises for bodily needs, and sexual conduct. We're sure if this Retail Store is allowed, that we will notice more trash, probably increased crimes being committed, possibly drug-related paraphernalia, and disregard for our personal property rights. Think about the families adjacent to this proposed site they will not feel safe at all. We already have had out gate post run into and destroyed. Also in the past we have had a person drive from Farm Loop across the Glenn Highway without stopping and cause a bad wreck. We have had drivers go through out fence alongside the Glenn Highway several times over the years.
- 7. The value of our property will be impacted. Who would want to live in this area if there's a marijuana retail shop nearby? Would you and your family be comfortable, out in the country with potential marijuana customers coming into our neighborhood?
- 8. We are out of the Palmer City Limits, so the only police protection we would have would be the State Troopers, who are spread thin over the Borough. I'm sure all of us will have our weapons ready and our doors locked and we'd be apprehensive and worry about the type of people who would be customers of the potential retail shop, as well as other criminal elements who would follow in their path. There will be money and marijuana on the premises of the proposed retail site, so there will be more crime.
- 9. There are already marijuana retail stores conveniently located in the Valley, near Wasilla and Palmer. There is no need to have another in this rural area. WE DO NOT WANT IT HERE.

We are adamantly opposed to the proposed retail marijuana site for all the above reasons. We do not see ANYTHING good that could come out of it. This is NOT the place for marijuana to be sold. It should be in a more regulated, trooper/police presence, rather than a rural, family-oriented farming area. It is NOT to the communities' best interest to have a retail shop anywhere in the Farm Loop area. The proposers of this application must look at a site where it is more controlled and regulated by a police presence, not in a rural less-populated area where our values (and possibly our lives) would be impacted by unsavory activities from people who care only about themselves. We care about each other in this Farm Loop area.

Please review mine and other's comments and recognize this is not a knee-jerk reaction to having a marijuana retail store in "our back yard" (NIMBY reaction), but is a recognition that this area is not the place for a marijuana retail store.

Please deny this application completely.
