RE: Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on January 21st and February 18th, 2021. Eleven Notice of Violations were sent on January 25th, 2021. Thirteen Notice of Violations were sent on February 18th, 2021.

Re: Failure to pay taxes under AS 43.61.010 by licensed marijuana cultivation facilities

Pursuant to Alaska Statutes and Regulations, AS 43.05.230(e), AS 43.61.030 and 15 AAC 61.020, the Department of Revenue will inform the Marijuana Control Board of licensed cultivators that have failed to pay tax due or file a return as required by law.

As of today, there are 11 licensed cultivation facilities that failed to pay marijuana excise taxes as required under AS 43.61.010. The list below does not include accounts that are compliant on payment plans or out of business. It also does not include accounts that have past due balances under \$200. If we reported the total number of past due accounts for tax periods through November 30, 2020, we would report 43 licensed cultivators owing a total of \$2,009,372.


