Glen Klinkhart, Director Badge

At the June 23-24, 2021, meeting, the board opened this project and sent out the draft with amendments for public comment. The comment period closed August 11, 2021. One comment received.

The changes which are in 3 AAC 306.710(c) and 3 AAC 306.715(a) propose to allow the employee badge to be displayed either on the person or in a readily recognizable or accessible manner.

Options for the board:

- Vote to adopt
- Amend and adopt (or amend and send out of public comment if necessary)
- Send back to staff for more work
- Close the project without action

- 3 AAC 306.710(c) is amended to read:
- (c) In a restricted access area, a licensee, employee, or agent of the marijuana establishment shall https://example.com/have on display.either on the person or in a readily recognizable or accessible manner. [WEAR] a current identification badge bearing the person's photograph. A person under 21 years of age may not enter a restricted access area. Any visitor to the restricted access area must

 an identification badge issued by the marijuana establishment at all times when on the marijuana establishment's licensed premises.
