FROM: Jason M Davies CJTII RE:Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on June 22st and July 23rd, 2021. Twenty-one Notice of Violations were sent on June 23rd, 2021. Fourteen Notice of Violations were sent on August 3rd, 2021.

On June 24th the Department of Revenue sent AMCO a list of out of business marijuana cultivations that are still delinquent of their marijuana excise tax. The Department of Revenue combined both active and expired licenses that owe taxes on their July 23rd memo. Highlighted in the July 23rd memo are non-active licensee's.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.

Pursuant to Alaska Statutes and Regulations, AS 43.05.230(e), AS 43.61.030 and 15 AAC 61.020, the Department of Revenue will inform the Marijuana Control Board of licensed cultivators that have failed to pay tax due or file a return as required by law.

As of June 16, 2021, there were 21 licensed cultivation facilities that failed to pay marijuana excise taxes as required under AS 43.61.010. The list below does not include accounts that are compliant on payment plans or out of business. It also does not include accounts that have past due balances under \$200. If we reported the total number of past due accounts for tax periods through April 30, 2021, we would report 56 licensed cultivators owing a total of \$2,066,233.


