FROM: Jason M Davies CJTII RE:Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on January 18<sup>th</sup>,2022, February 22<sup>nd</sup>, 2022 and March 23<sup>rd</sup>, 2022. Twenty-one Notice of Violations were sent on January 18<sup>th</sup>,2022. Twenty Notice of Violations were sent on February 23<sup>rd</sup>, 2022. Seventeen Notice of Violations were sent March 23<sup>rd</sup>, 2022.

The Department of Revenue combined both active and expired licenses that owe taxes on all three lists from January to March 2022 on their memos.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.

Pursuant to Alaska Statutes and Regulations, AS 43.05.230(e), AS 43.61.030 and 15 AAC 61.020, the Department of Revenue will inform the Marijuana Control Board of licensed cultivators that have failed to pay tax due or file a return as required by law.

As of January 18, 2022, there were 31 cultivation facilities that failed to pay marijuana excise taxes as required under AS 43.61.010. The list below does not include accounts that are compliant on payment plans or that have past due balances under \$200. A license number with an asterisk next to it indicates that the license is no longer active. If we reported the total number of past due accounts for tax periods through November 30, 2021, we would report 49 cultivators owing a total of \$2,120,913.




