RE: Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on June 28th, 2022, July 21<sup>st</sup> and August 25<sup>th</sup>, 2022. Twenty-One Notice of Violations were sent on June 28th, 2022. Twenty-Seven Notice of Violations were sent on July 21<sup>st</sup>, 2022. Twenty-Eight Notice of Violations were sent on August 26<sup>th</sup>, 2022.

The Department of Revenue combined both active and expired licenses that owe taxes on both lists from April and May 2022 on their memos.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.




