- #12316 Retail Marijuana Store license controlling interest transfer
- #12317 Limited Marijuana Cultivation Facility license controlling interest transfer
- #12318 Marijuana Product Manufacturing Facility license controlling interest transfer application

Licensee Anchorage Bowl LLC entity official Shelton Landon is requesting a time extension on their three renewal application deadline(s) so that the related three pending controlling interest transfer applications be processed first, thus removing the requirement for outgoing entity officials Arthur Kanack and Jon Fischer to participate in the 2022-2023 renewal application process. None of the three licenses received a Notice of Violation between July 1, 2021 and June 30, 2022. Mr. Landon is formally disputing a creditor's lien being placed upon the 12316, 12317 and 12318 licenses for unpaid debts.

Based upon prior precedent set at the previous January 20-21, 2022 meeting in which the board deemed transfers and renewal applications complete regardless of civil disputes, AMCO is asking the board to

a) consider deeming the three renewal applications complete as is;

b) consider approval of the three renewal applications;

c) consider approval of the three controlling interest transfer applications; and d) consider the creditor's formal request for lien attachment as a delegation item to the three licenses.

Statutory and

3 AAC 306.035(a) "Any marijuana establishment with a license in active and operating status on or before June 30 of the current year must submit the completed renewal application, along with the license renewal fee, to the director not later than June 30 of each year. If June 30 falls on a Saturday or Sunday, the deadline is extended to 4:30 p.m. on the first business day following June 30. If mailed, the complete renewal application and fee must be postmarked by the deadline."

Regulatory Authority:

3 AAC 306.035(g) ") If a marijuana establishment required to submit a renewal application under (a) of this section fails to deliver a complete license renewal application or fails to pay the required renewal fee and the late renewal application fee on or before August 31 of each year, that marijuana establishment license expires at 12:00 midnight on August 31 of that year. A holder of an expired license shall immediately surrender the license to the board."
