RE:Tax Delinquency Notice of Violations

The Department of Revenue provided lists of tax delinquent licensed marijuana cultivation facilities to AMCO Enforcement on October 27th, 2022 and November 23rd, 2022. Seventeen Notice of Violations were sent on October 28th, 2022. Eighteen Notice of Violations were sent on November 25th, 2022.

The Department of Revenue combined both active and expired licenses that owe taxes on both lists from April and May 2022 on their memos.

Attached are the memo's provided by the Department of Revenue and Notice of Violations separated by responses and non-responses.
