## • LICENSE REINSTATEMENTS

Jane S. summarizes the background of the requests before the board. Director Wilson reviews the regulations related to the requests. Jana Weltzin, counsel for the licensee, and Norvin Perez, licensee, are present on Zoom.

## Bruce S. motions to reinstate licenses 13217, 13221 and 13222. Ely C. seconds.

Ms. Weltzin provides additional background information. There had been a change of management which led to a lack of communication between management. The entity is currently in good standing with Department of Revenue and they have not been operating since expiration.

Jane S. reads 3 AAC 306.080(c).

*Eliza M. asks if the retail is connected to the Urgent Care in Juneau and do they provide services for overuse of substances. Mr. Perez states they refer out to the appropriate agencies. That level of care to treat substance abuse requires a special license and they are not set up for that service.* 

*Ely C. says there is no ambiguity in the regulation for denying a reinstatement request. Director Wilson further clarifies the standards set forth in the regulation. Kevin Higgins agrees and clarifies the wording around the deadlines.* 

*Mr.* Perez states they are still paying their taxes even under the administrative hold and there have been no violations of the that hold.
