Re: General Public Comment to the Marijuana Control Board



The Alaska Marijuana Industry Association (AMIA) would like to acknowledge this last year's regulatory work. The Marijuana Control Office and Board has made leaps and bounds in regulatory changes that are helping cannabis businesses and facilitating economic growth. While we still have changes and obstacles to overcome in the coming years this body of government is truly working together and creating a better regulatory framework. Thank you AMCO and board members!

In the last few months changes to regulations, such as, introduction of seeds and clones and being able to revoke acceptance of cannabis and cannabis products have gone into place and our helping facilitate commerce. There has only been one issue raised recently and that's the language of "without compensation" in 3 AAC 306.405(a)(9). We believe the intent of the board is to create regulations that promote honorable commerce. This language of the regulation, while having good intent of preventing diversion, has also effectively created a scenario where in order to purchase reputable genetics from legal sources either an owner or staff member must pay and must give it to the company without reimbursement. What other industries operate this way and was this the intent of the board?

The issue of individual plant tags is still a high priority for our membership. Many states have transitioned regulatory language that does not require individual radio frequency tags on each plant. Instead, allowing a batch of plants to be under a single tag. The current tags are not perfect either. We know that moisture affects these tags and can make them inoperable for scanning. And while the board did open a regulations project to change tagging height requirements, it still only addresses the issue partially. We believe that our industry is capable of maintaining excellent seed to sale tracking, without such a heavy cost to cultivators. A single cultivation business can spend upwards of 5 thousand dollars in a single year on METRC tags alone!

Lastly, we want to again acknowledge all the hard work and public service provided by Nick Miller and Eliza Muse. We would not be where we are at as an Alaskan cannabis industry without your effort to understand and create regulations that facilitate commerce while keeping public heath and safety in mind. These shoes will not be filled easily, you both have gone above and beyond in your roles as regulators, and we want to take a moment to acknowledge both of you. Thank you for your service!

It was also brought to our attention that the head of enforcement, Mr. James Hoelscher has found a new position as Director of VPSO. We know he will be a great fit for that program and sincerely appreciate the time Mr. Hoelscher took to educate himself in a new industry and facilitate a culture where self-reporting was rewarded. Mr. Hoelscher has been a very important voice for public safety, helping to guide our nascent industry. Thank you, James.

We would also like to give a nod of sincere gratitude to Ms. Carrie Craig for her excellence while with the AMCO office. Carrie's dedication to not only the program but the people within it, will be missed. We have appreciated you and the respect you have shown to our industry. Thank you Carrie!

Hello! My name is Tyler, I own a cannabis company in Anchorage called Rolling Stoned Hemp Co. We do delivery! Cool right? We're rolling in more than just one way. See what I did there?

We're going to be advertising that message across Alaska radio, and other public platforms soon as well. Almost verbatim. Can't wait!!! Exciting right? Good thing it's federally legal! DAMN that's really really gonna piss some people off in the "real" cannabis industry! Am I right? Im sure you guys will reach out to stations to try and shut that down so this will be wonderfully fun!

The fine gents running the hemp program mentioned to me amco walked all over them and forced these new rules into place. They also mentioned to me that you guys wouldn't even be able to figure out how to write up a fine! So I guess we'll see if the goons show up. But seriously, be better than that guys! Enough with your criminal prosecution and fine threats which I've already received two of from the hemp program.

You should know, I've had my fair share of legal run ins. Look me up! I'm sure you'll be just fucking thrilled you gotta deal with this! LOTS of people know I am not afraid to get down and dirty with the government! Hell I even won a federal criminal trial! And I give ZERO craps.. about what it might cost in money, time, or even my freedom to prove my point. My point here is that Im no longer a criminal. I know the law and follow it. I'm someone who got out of the system, got a college education, started multiple business, and am part of the small percentage of people that get out of the system and become successful.

- 2. The Supremacy Clause of the Constitution of the United States
