I am writing regarding the Notice of Violation that Taku Horticulture received on January 3rd via email.

I would like to explain why these taxes are owed and our plan to correct the balance. On November 4, 2022 we received an email from Savannah Ritter requesting an audit from November 2020 thru July 2022. To our surprise almost a year later on October 24, 2023 we received a letter with an audit assessment packet showing that we had back taxes due in the amount of \$26,075.05. This not only included items that were not entered on initial reports but also showed interest, and penalties. This was shown as due immediately.

After researching we realized that we had been filing our taxes with the wrong metrc report. When things were being hubbed, they were not showing up on the report we were using to file taxes. This has since been fixed and will no longer ben an issue.

We do appreciate that instead of yearly audits now, there is someone checking reports monthly, we really appreciate this. John has been a tremendous help with any questions that might arise on these reports.

As far as getting the payment made for the late taxes, and the interest/penalties that were incurred, we have asked to set up a payment plan but was told no. We are trying to get this debt settled asap, but with it being slow winter months we are finding it hard to pay in full. Is there a way to please set up a payment plan to get this amount taken care of? What are some options that we can have, as we want to make this right.
