Dear Director Wilson,

I am responding to the Notice of Violation (case AM 24-0015) dated January 3, 2024 concerning our delinquency on paying state excise taxes. We do have a backlog of excise taxes due to the results of an audit that was completed in November 0f 2023. We were remiss in filing accurate returns for several months during the years of 2020 to 2022. These errors were mostly clerical in nature by either in failing to include some transports or failing to do accurate arithmetic for other transports. These errors were in no way intentional or trying to get around taxes that we know that we owe the state. Some of the tax liability that the Department of Revenue (DOR) has listed is due to interest and penalties that the DOR applied for these time periods. We are scheduled for a hearing on January 17th, 2024 to resolve that issue one way or another. Nevertheless, I have applied for a payment plan with the DOR to cover these past taxes determined from the audit. We are, at this writing, up to date on the rest of our tax liability for all other tax periods.

I have been paying marijuana excise taxes to the state since 2016 and to this date I have paid over \$1,300,000 in taxes during 86 tax periods. I have rarely been late on my taxes and, if I was, the tardiness has always been taken care of in a matter of weeks. I realize that this audit is an exception to that, but once my appeals have been heard on January 17th, I will honor that ruling.
