Bringing this back to the Board to consider Law's **proposed edits** to the regulations draft the board approved at the September 2024 meeting. Those edits include definitions of both delta-9 and delta-8. This project is still in the initial review phase by Law.

Options for the board:

- Move to amend and approve and then send to Law to continue initial review. (agency attorney to advise.)

- Table the regulations project
- Close the regulations project

3 AAC 306.560 is amended to read:

## 3 AAC 306.560. Potency limits per serving and transaction for edible marijuana

**products.** A marijuana product manufacturing facility may not prepare a marijuana product with potency levels exceeding the following, as tested in compliance with 3 AAC 306.645:

(1) for a single serving of a marijuana product, not more than 10 milligrams of active tetrahydrocannabinol (THC) or <u>delta-9-THC</u> [DELTA 9];

(2) in a single packaged unit of a marijuana product to be eaten or swallowed, not more than 10 servings or 100 milligrams of active THC or <u>delta-9-THC</u> [DELTA 9]; the THC content must be homogenous, or evenly distributed throughout the marijuana-infused product. (48) "total THC" means the sum of <u>delta-9-THC, delta-8-THC,</u> [THC] and (0.877) \* (THCA)<u>;</u> [.] 3 AAC 306.990(b) is amended by adding new paragraphs to read:

(54) "delta-8-THC" means delta-8-tetrahydrocannabinol concentration

(A) determined by a post-decarboxylation chemical analysis; and

(B) found in only trace-to-very-small quantities in a cannabis plant, and

virtually all of which is found in a marijuana product that is isomerized from hemp-

derived CBD;

(55) "delta-9-THC" means delta-9-tetrahydrocannabinol concentration determined
